PROJECT AGREEMENT ON IMPROVING TRACHOMA CONTROL SERVICES FOR INDIGENOUS AUSTRALIANS

1. This Schedule has been developed in accordance with clause 16(a) of the Project Agreement on Improving Trachoma Control Services for Indigenous Australians. It will commence as soon as it is agreed between the Commonwealth and Queensland, and expire on 30 June 2021 or on completion of the project, including final performance reporting and processing of final payments against milestones.
2. In accordance with clause 8 and 17 of the Agreement, milestones, their relationship to outputs, expected completion dates, relevant reporting dates and expected payments are set out in Table 1.

	(vi) All contacts of those identified children receiving treatment at the same time where community-wide treatment is undertaken, be treated within a two week period;		
	(vii) In communities where trachoma prevalence is $\geq 5\%$ (where there is no obvious clustering of cases) and in all communities where prevalence is $\geq 20\%$ and annual screening is not being undertaken, community-wide treatment is undertaken on the advice of an ophthalmologist.		
	(viii) Following screening and treatment undertake related follow-up activities as required;		
	(ix) 100% of children screened assessed for clean faces;		
	(x) At least 10% of adults aged over 40 in trachoma-endemic regions screened for trichiasis;		
	(xi) Trichiasis referral, surgery and recall system maintained with all diagnosed adults;		
	(xii) 100% of adults diagnosed with trichiasis provided with opportunities to attend a referral;		
	(xiii) Sample of 1-4 year olds in 'at-risk' communities screened as guided by the National Trachoma Surveillance and Control Reference Group;		
	(xiv) 100% of children identified with active trachoma offered treatment;


