I am pleased to advise of Australian Government funding for 6 Black Spot projects within the Northern Territory under the Nation Building Packages announced in December 2008 and February 2009.

I have:

- approved, under Section 70 of the *AusLink (National Land Transport) Act 2005* (the AusLink Act), the projects listed in the schedule to the attached approval instrument ZPT3071 - ZPT3076 as AusLink Black Spot Projects for the purposes of the Act; and
- approved the provision of funding for these projects under Section 78 of the AusLink Act.

Details of the approved projects are set out in the attached instrument and schedule.

As part of the Government's Nation Building and Economic Stimulus Packages announced in December 2008 and February 2009, I ask that the Northern Territory report on the employment impact of the additional Black Spot funding. 
