I am pleased to advise of Australian Government funding under the Black Spot Program for 14 projects within South Australia for the 2009-10 program year and 52 projects under the Nation Building Packages announced in December 2008 and February 2009.

I have:

- approved, under Section 70 of the *AusLink (National Land Transport) Act 2005* (the AusLink Act), the projects listed in the schedules to the attached approval instruments SPT7018 and SPT3394 - SPT3446 as AusLink Black Spot Projects for the purposes of the Act;
- approved the provision of funding for these projects under Section 78 of the AusLink Act;
- approved under Section 9 of the AusLink Act, the projects listed in the schedule to the attached approval instrument SPT3401 - SPT3413 as Black Spot National Network projects for the purposes of the Act; and
- approved the provision of funding for these projects under Section 17 of the AusLink Act.
