Childhood Development (‘VIC’)



1. BACKGROUND:

- A. The Commonwealth of Australia as represented by the Department of Education, Employment and Workplace Relations and You entered into an Agreement (“**the Agreement**”) regarding the Nation Building and Jobs Plan.
- B. The parties now wish to vary the Agreement on the terms and conditions contained in this Variation.
- C. The Agreement requires that a variation be in writing and signed by both parties.

2. VARIATION

IT IS AGREED as follows:

1. This Contract Variation commences on 1 June 2009, or the date of execution, whichever is the later.
2. The Contract is varied by:
 - A. Deleting Schedule 2A and replace it with the attached Schedule 2A.

AUSTRALIAN GOVERNMENT BUILDING THE EDUCATION REVOLUTION PROGRAM FUNDING

Item A: BER ELEMENT [clause 3.1]

National School Pride Program

Item B: FUNDING PERIOD [clause 3.1]

This Schedule applies to Funding authorised for the Period from 2008-09 to 2010-11

Item C: FUNDING AMOUNT [clause 3.1]

Total Funding available including the administration fee is \$207,897,375 (exclusive of GST).

Item D: FUNDING INSTALMENTS [clause 3.1]

Payments in Column 1 will be made at the times set out in Column 2.*



Instalment 1	\$62,848,000	Payment will be made on the 7 th day of the month following the month in which the agreement is executed by all parties.
Instalment 2	\$ 73,596,375	Payment will be made on the 7 th day of the month following receipt and acceptance by DEEWR of the detailed statement of income and expenditure including expenditure to each school for the previous financial year in accordance with clause 4.1.1(c) of this agreement. This payment will not be made before 7 July 2009.
Instalment 3	\$ 71,453,000	Payment will be made on the 7 th day of the month following acceptance by Us of the previous monthly report. This payment will not be made before 7 November 2009.

Note: Milestone payments are 50 per cent on commencement and 50 per cent on completion.

We may withhold some, or all, of the payment of any funding instalment, subsequent to instalment 1 in the table above, if You have not paid to your schools at least 50 % of the funding paid to You by Us under this agreement from the previous instalment.

The Commonwealth will not provide any additional Funds to You to meet any GST liabilities You incur as a result of subcontracting any part of the performance of Your obligations under this Agreement.

The date for payment is within 30 days of the date specified in the Table and after acceptance by the Commonwealth of:

- (a) any Report required by the Guidelines; and
- (b) if requested by the Commonwealth, a correctly rendered tax invoice;
- (c) delivered by You to the Commonwealth in accordance with this Agreement.

You may use \$3,072,375 of the Funding Amount in Item C of this Schedule for your administrative expenses associated with carrying out your obligations under this agreement as follows:


