1. BACKGROUND:

- A. The Commonwealth of Australia as represented by the Department of Education, Employment and Workplace Relations and You entered into an Agreement ("the Agreement") regarding the Nation Building and Jobs Plan.
- B. The parties now wish to vary the Agreement on the terms and conditions contained in this Variation.
- C. The Agreement requires that a variation be in writing and signed by both parties.

2. VARIATION

IT IS AGREED as follows:

1. This Contract Variation commences on 1 May 2009, or the date of execution, whichever is the later.
2. The Contract is varied by:
 - A. Deleting Schedule 2B and replace it with the attached Schedule 2B.



Instalment 6	\$131,994,500	Payment will be made on the 7 th day of the month following acceptance by Us of the previous monthly report. This payment will not be made before 7 March 2010.
Instalment 7	\$106,821,375	Payment will be made on the 7 th day of the month following receipt and acceptance by DEEWR of the detailed statement of income and expenditure including expenditure to each school for the previous financial year in accordance with clause 4.1.1(c) of this agreement. This payment will not be made before 7 July 2010.
Instalment 8	\$100,570,375	Payment will be made on the 7 th day of the month following acceptance by Us of the previous monthly report. This payment will not be made before 7 September 2010.
Instalment 9	\$100,570,375	Payment will be made on the 7 th day of the month following acceptance by Us of the previous monthly report. This payment will not be made before 7 January 2011.
Instalment 10	\$100,570,375	Payment will be made Payment will be made on the 7 th day of the month following acceptance by Us of the previous monthly report. This payment will not be made before 7 March 2011.

We may withhold some, or all, of the payment of any funding instalment, subsequent to instalment 1 in the table above, if You have not paid to your schools at least 50 % of the funding paid to You by Us under this agreement from the previous instalment.

Note: Milestone payments are 25 per cent on commencement: 25 per cent on milestone one: 25 per cent on milestone 2: and 25 per cent on completion. For projects less than \$0.85m, payments are 50 per cent on commencement 50 per on completion.




