## VICTORIAN IMPLEMENTATION PLAN Element 3: Increase access to and use of maternal and child health services by Indigenous families (New Directions – an equal start in life for Indigenous children)

The National Partnership required the State to allocate funding for the New Directions: Mothers and Babies Services funding commitment to a total of \$4.5 million over the period of the National Partnership. This matched funding was identified from 2008/09 State budget initiatives including; Enhanced Maternal and Child Health (\$2.875m), Supported Playgroups (\$500,000), Aboriginal Best Start (\$600,000), Healthy Mothers and babies (\$525,000).

The Victorian component of Element 3 has been fully implemented in Victoria. Future reporting will be incorporated into the State reporting requirements with services providers as part of their Victorian Service Agreements and reflected in performance measures for the National Partnership with DEECD or DHS.

The following implementation plan reflects only the Victorian component of Element 3. An implementation plan for the remainder of the Element 3 totalling \$4.0 million will be provided by the Commonwealth Department of Health and Ageing
