- Initiatives in Project 1 will be agreed between the Commonwealth and New South Wales following an application and assessment process, and will be reflected in the Project Plan in accordance with clause 10(c) of the Agreement and Table 1 of this Schedule.

Performance requirements

Reporting

5. The State will provide annual progress reports with each report covering all of the projects in clause 1, during the operation of the Agreement up to June 2017.
