NATIONAL PARTNERSHIP AGREEMENT ON HOMELESSNESS: SCHEDULE A

PRELIMINARIES

This Project Plan is a schedule to the National Partnership Agreement on Homelessness (the Agreement) and should be read in conjunction with that Agreement.

TERMS OF THIS PROJECT PLAN

This Project Plan will commence on 1 July 2017 or when it is agreed between the Commonwealth of Australia, represented by the Minister for Social Services, and NSW, represented by the Minister for Families and Community Services, whichever is the later, and will cease on completion or termination of the Agreement.

As a schedule to the Agreement, the purpose of this Project Plan is to provide the public with an indication of how frontline homelessness services are intended to be delivered and demonstrate NSW's capacity to achieve the outcomes of the Agreement.

This Project Plan will cover the one-year period of 2017-18.

This Project Plan may be varied in accordance with clauses 23,47,49 and 50 of the Agreement.

PART ONE: STRATEGIC OVERVIEW OF IMPLEMENTATION STRATEGY

Table 1: Strategic overview of implementation

1. What is the relevant context for New South Wales, including any reform directions being taken to improve homelessness outcomes?

Following sector wide reforms, the new Specialist Homelessness Services (SHS) commenced service delivery across NSW during 2014-15. SHS are a vital part of the service system. They intervene early to prevent homelessness and assist people who are already experiencing homelessness to break the cycle of homelessness for good. They contribute to the achievement of the following four SHS Program level outcomes:

- people who are at imminent risk of homelessness are identified and supported to remain safely in their existing housing, or to secure stable housing
- people who experience homelessness are rapidly and safely rehoused
- people who are in crisis are provided with safe and secure accommodation and supported to access stable housing
- people who are rehoused after becoming homeless are supported to stay housed.

A number of complementary homelessness Programs were also implemented in 2014-15 to support and complement the SHS services and address identified gaps. These included the Homelessness Youth Assistance Program, the Service Support Fund and the Inner City Restoration Fund.

In November 2015, the Minister for FACS announced the extension of contracts for homelessness services to 2020. The funding extension seeks to increase stability in the sector, and to strengthen and maintain existing partnerships.

The extension is also linked to a commitment to strengthen the collective focus on achieving and sustaining client outcomes. Over the course of this 2017-2020 contracting period, FACS will work collaboratively with the SHS sector to identify and test new outcome measures and performance indicators.

Key areas of focus over the next three years will be:

- agreeing and testing a set of collaboratively designed outcome measures and performance indicators for homelessness services
- building the systems to measure and monitor these agreed measures and indicators
- implementing and evaluating new and innovative approaches that incorporate financial and non-financial performance incentives
- undertaking an outcomes and economic evaluation of the homelessness system in NSW
- strengthening the capacity of the homelessness sector in relation to outcomes measurement.

The 2017-18 NPAH will continue to support the sustainable implementation and strengthening of the NSW homelessness service system and will:

- enhance client service delivery within services across NSW;
- strengthen service delivery capacity within the service system; and
- support the introduction of innovative service delivery approaches.
- 2. What frontline services or programmes will New South Wales deliver in 2017-18 to meet the outcomes of the Agreement.

NSW will deliver 10 programs under this project plan which will contribute to the outcomes outlined in 14(a) of the agreement. These include:

- Homeless Youth Assistance Program unaccompanied children and young people who are homeless, or at risk of homelessness, will be provided with integrated support and accommodation with the aim of effectively reconnecting them with their families, wider support networks or enabling them to transition to longer-term supported accommodation.
- Housing & Support for Rough Sleepers this program is being developed to address the acute and growing shortage in medium-term (transitional) accommodation to target rough sleeping. The service will provide access to an additional 120 transitional houses and support packages to target rough sleepers who are unable to access this type of housing due to a lack of capacity. This program replaces the Connect 100 program (previously funded through NPAH). Advanced payments for 2017/18 have been made to continue services for existing Connect 100 clients.
- Restoration funding for inner city homelessness services continuation of homelessness funding to the inner city in recognition of concerns that the scale and pace of the SHS reforms in the inner city of Sydney need more time to ensure the sector can fully implement strategies to tackle and reduce inner city drift.
- **Service Support Fund** –which funds small to medium sized non-government organisations to deliver homelessness services across NSW to support and complement the new SHS service models.
- **Temporary Accommodation** people who are homeless will receive emergency accommodation and access to assistance to find long term solutions to homelessness.
- Link2home is the new homelessness information and referral service that operates 24 hours a day, seven days a week and brings together three previous homelessness phone lines into one single state-wide service. It supports clients who are homeless or at risk to access the information they need, get help with accommodation and be referred to local homelessness services. Link2home has access to real time vacancy information.
- **Private Rental Subsidy** assists clients who have been approved for priority status on the NSW Housing Register, have a disability and are at risk of homelessness in their current accommodation, to access a housing solution as well as support services through Specialist Homelessness Services to ensure they can sustain their tenancy and address other issues contributing to their homelessness situation.
- Start Safely Subsidy provides assistance to people experiencing homelessness as a result of domestic and family violence to secure private rental accommodation so that they don't have to return to the violent situation, or remain homeless. The program facilitates a rapid rehousing response while ensuring that clients are linked into Specialist Homelessness Services so they can access support to sustain their tenancy and address their homelessness needs.

- Private Rental Market Assistance supporting clients at risk of homelessness to establish, or keep, a sustainable tenancy in the private sector. This includes brokering the establishment of individual private rental tenancies with local real estate agents and landlords, while ensuring relevant support arrangements through Specialist Homelessness Services are in place to develop tools and capabilities to sustain the tenancy and ensure they don't fall back into homelessness or prevent them from becoming homeless.
- Staying Home Leaving Violence supporting victims of domestic and family violence through promoting housing stability and focusing on preventing victims becoming homeless. Services funded under the program provide women with intensive case management which is long term and needs based. The Program is based on intensive case work with key agencies such as the Police, courts, health services, social housing providers and relevant non-government organisations.

Critical to the implementation of the homelessness services system in NSW, including the NPAH funded Programs, has been the establishment of District Homelessness Implementation Groups (DHIGs), which are comprised of key specialist homelessness NGO service providers as well as other key NGO and government agencies within the homelessness service system. Funded positions support these critical governance structures as well as play an active service role in coordinating and collaborating with providers to strengthen service models and referral pathways, achieve service delivery improvements, consolidate links between relevant providers and government agencies to drive system-wide change to prevent and reduce homelessness at a local level, based on local need.

3. How will New South Wales focus on the priority outputs, including where this will draw on any new or current innovate approaches?

Under this project plan, New South Wales will allocate a combined level of Commonwealth and NSW funding of more than \$32.5 million towards the priority outputs 15(a), 15(b) and 15(c). This does not include state-wide programs such as temporary accommodation, Link2Home, private rental market assistance and subsidies as these are demand driven, with clients provided assistance and referral to specialist homelessness services, when the need arises.

Key programs contributing to these outputs include:

1. Output 15 (a) - support services for women and children experiencing domestic and family violence, including support to stay in their present housing where it is safe to do so.

Staying Home Leaving Violence (SHLV) – SHLV is an innovative and specialised domestic and family violence program aimed at promoting victims' housing stability and preventing homelessness. The program helps women who have separated from a violent partner or family member (and their children) to remain safely in their own home, or another home of their choice.

Start Safely Subsidy – this program provides time limited assistance to those escaping from domestic or family violence who are homeless or at risk of homelessness, so that they don't have to return to the violent situation or remain homeless. Clients are linked into support from Specialist Homelessness Services and other providers who specialise in domestic and family violence.

Restoration funding for inner city homelessness services – one of the eight inner city restoration services is specifically focused on providing a rapid rehousing response for women and children experiencing domestic and family violence who are homeless, or at risk. An additional two inner city restoration services are specifically for women, with one for women with complex needs and the other for women who are survivors of childhood sexual abuse. These services complement the broader response to women, including those experiencing domestic and family violence, in the inner city through the Specialist Homelessness Services and Service Support Fund services.

Service Support Fund services – there are six Service Support Fund (SSF) services that have a specific response for women and children experiencing domestic and family violence, including:

- the Aboriginal Women and Children Crisis Service in the Sydney District which operates a refuge for homeless Aboriginal women and children experiencing domestic violence, and also provides support services for women engaged in the court system; and
- the Homeless Multicultural Women Integrated Support Service Project in the Western Sydney District which delivers case management support for women and children experiencing domestic violence from a culturally and linguistically diverse (CALD) background.

An additional four SSF services are specifically for homeless, or at risk, women with specialised responses for mental health and complex clients, drug and alcohol, asylum seekers and women exiting custody.

The SSF services complement the broader Specialist Homelessness Services response to homeless or at risk women NSW, including those experiencing domestic and family violence.

In addition to the above programs which deliver specific support services for women and children experiencing domestic and family violence, the **Temporary Accommodation**, **Link2Home**, **Private Rental Subsidy** and **Private Rental Market Assistance** programs also support this client group. These services are demand driven, with clients provided assistance when the need arises.

In 2015–16 there were 23,171 clients experiencing domestic and family violence which makes up 33% of the 69,715 SHS clients that year.

2. Output 15 (b) - support services to young people aged 16 to 24 years who are homeless or at risk of homelessness to re-engage with their family where it is safe to do so, and maintain stable accommodation; and Output 15 (c) - support services for children aged 12 to 15 who are homeless or at risk of homelessness.

In 2015-16, SHS services provided assistance to 13,743 young people (unaccompanied, aged 15 to 24), which was 20% of all SHS clients.

Restoration funding for inner city homelessness services – two of the eight inner city restoration services include a response for young people:

- The Inner City Sydney Homelessness Service (The Salvation Army) continues to provide crisis beds at 2013–14 levels, while a staged approach to the redistribution of congregate crisis accommodation is undertaken. It provides prevention and early intervention, rapid rehousing, crisis and transition responses and intensive responses for clients with complex needs
- The Inner City Sydney Homelessness Service (Mission Australia) provides support to young people through:

- The Crossing a long-term intensive case management service for young people, aged 18-25 years, who are homeless, or at risk of homelessness, and finding it difficult to access other support services. The service also supports young people with complex issues, multiple needs and/or challenging behaviours; and
- The Shopfront legal service a free legal service for homeless and disadvantaged young people aged 25 and under.

Service Support Fund services – there are nine Service Support Fund (SSF) services that have a specific response for young people, including:

- St Laurence Youth Services which provides transitional accommodation and support for 15–18 year olds leaving crisis care in the eastern suburbs of Sydney, as well as support programs for 18–24 year olds who are homeless, but may be accommodated in other services.
- The Helping Hand service which provides specialist support services to young people 16 years
 of age and over who are homeless or at imminent risk of becoming homeless in the St
 George and Sutherland Local Government Areas. Priority clients are Aboriginal people and
 people from culturally and linguistically diverse backgrounds, including refugees and newly
 arrived migrants.

The SSF services complement the broader Specialist Homelessness Services response to young people in NSW.

The Homelessness Youth Assistance Program (HYAP) funds service providers to deliver targeted service responses for unaccompanied children and young people aged 12 to 15 who are homeless, or at risk of homelessness. HYAP complements the range of non-statutory responses funded or delivered by FACS to support vulnerable children and young people under 16 years of age.

In addition to the above Programs which deliver specific support services for young people, the **Temporary Accommodation, Link2Home, Private Rental Subsidy** and **Private Rental Market Assistance** Programs also support this client group. These services are demand driven with assistance when the need arises.

In 2015-16, Link2home received a total of 175,880 calls, of which 21,058 (12%) were from clients between the age of 15-24 years.

4. Which geographical area(s) will New South Wales prioritise in 2017-18 when considering expenditure on the priority outputs listed at clauses 15(a), 15(b) and 15(c) of the Agreement, and what services are being provided to these areas?

The NSW Government uses a range of methodologies to allocate expenditure towards targeted service responses for vulnerable client groups. The NPAH funding is being invested to meet service needs across the State and to complement services that are funded from other sources.

Below are examples of how expenditure is allocated towards the priority outputs listed at clause 15(a), 15(b) and 15(c) in particular geographical areas of NSW for the programs which form part of the 2015-17 National Partnership Agreement on Homelessness:

Homelessness Youth Assistance Program

HYAP funding has been distributed to FACS Districts via a Resource Allocation Model (RAM) that considers both need and demand factors. Due to the unique nature of the client group, both homelessness and child protection data sets were used in the RAM. The three components to the RAM were:

- 12-15 year olds that received assistance from Specialist Homelessness Service (SHS) providers in 2012-13 (30%);
- 12-15 year olds that were reported at Risk of Significant Harm (ROSH), where homelessness was one of the reported issues (30%); and
- Base allocation to all Districts (40%).

This approach to allocating HYAP funding ensured it was weighted proportionally to those areas of NSW where need and demand is greatest, whilst also ensuring the specific geographic challenges faced by regional, rural and remote areas were acknowledged.

Staying Home Leaving Violence Program

The methodology for selecting the SHLV locations included:

- analysis of the rates of Domestic Violence related assaults numbers of Apprehended Domestic Violence Orders (ADVO); Breaches of ADVOs; Aboriginal population rates; and areas showing a significant increase in rates of domestic violence;
- consideration of existing local infrastructure capacity to support the program including presence of other domestic violence services; and
- consultation with FACS Districts with and government partners on the proposed locations.

Service Support Fund services were designed to complement the SHS and fill known gaps across the state, including services targeted at domestic and family violence and youth. The Inner City Restoration services ensure that homeless or at risk clients continue to receive services in the City of Sydney to allow a progressive implementation of strategies to tackle inner city drift (including the Housing & Support for Rough Sleepers initiative which will support homeless people to stay in or near their local communities), and increased access to services in regional areas created through funding increases under the SHS reform.

Start Safely specifically supports clients escaping from domestic or family violence that are homeless or at risk, on a demand and need basis across the State. The **Temporary Accommodation, Link2Home, Private Rental Subsidy** and **Private Rental Market Assistance** Programs also support clients across the State based on demand and need. This includes homeless or at risk clients escaping domestic and family violence and youth.

Examples of how NPAH funds are spent across NSW to support the priority outputs are:.

Sydney and South Eastern Sydney Districts

Sydney and South Eastern Sydney Districts have a diverse population in a range of highly urbanised areas and significant pockets of disadvantage as well as areas of high economic status. There is an ongoing drift of homelessness from the western parts of Sydney to the inner city and rough sleeping continues to be a focus of homelessness levels in the inner city.

The 2011 ABS Census shows that there were 9,569 homeless people in Sydney and South Eastern Sydney which represented 34% of the total homeless population in NSW on the Census night. The District overall experience significant numbers of domestic violence incidents with 2949 domestic violence-related Apprehended Violence Orders issued by the NSW Courts in 2013 (source: NSW

Bureau of Crime Statistics and Research).

The NPAH maintains services in the inner city, to allow a staged approach to tackling inner city drift The NPAH also funds a significant homelessness response in these Districts, particularly for young people and clients experiencing domestic and family violence, including:

Targeted Domestic and Family Violence services

- Staying Home Leaving Violence Eastern Sydney
- Staying Home Leaving Violence Redfern
- Service Support Fund Aboriginal Women and Children Crisis Service
- Service Support Fund Moving Forward (women's only service that includes a DFV component)
- Inner City Rapid Rehousing Response for Women Experiencing Domestic/Family Violence
- Provision of rental subsidy for people escaping domestic and family violence (Start Safely Subsidy Program)

Targeted youth services

- Support for unaccompanied Homeless Children and Young People under 16 years (HYAP) –
 Sydney District
- Support for unaccompanied Homeless Children and Young People under 16 years (HYAP) South Eastern Sydney District

Western Sydney District

The Western Sydney District has a population of 786,000 people and includes the largest urban Aboriginal population in the state (2011 ABS Census), with a total of 11,504 Aboriginal people. Western Sydney is also one of the most culturally diverse districts in the State, with almost 35 per cent of the population reported as being born overseas in the 2011 Census.

Western Sydney has high levels of homelessness and high demand and competition for the available affordable private rental options. The 2011 ABS Census shows that there were 3,516 homeless people in Western Sydney which represented 12% of the total homeless population in NSW on the Census night.

The District overall experiences significant numbers of domestic violence incidents, with 2,768 domestic violence-related Apprehended Violence Orders issued by the NSW Courts in 2013 (source: NSW Bureau of Crime Statistics and Research).

The NPAH funds a significant homelessness response for young people and clients experiencing domestic and family violence in the Western Sydney District, including:

Targeted Domestic and Family Violence services

- Staying Home Leaving Violence Blacktown
- Staying Home Leaving Violence Holroyd
- Staying Home Leaving Violence Parramatta
- Service Support Fund Homeless Multicultural Women Integrated Support Service
- Provision of rental subsidy for people escaping domestic and family violence (Start Safely Subsidy Program)

Targeted youth services

Support for unaccompanied Homeless Children and Young People under 16 years (HYAP) –
 Western Sydney District

Western NSW District

The Western NSW District includes some of the state's most diverse and remote communities. The area comprises more than half of NSW in land area, however the population is only around 4% of the total population in NSW. The dispersion and remoteness of a population impact on the cost of delivering homelessness services, and the small size of some of the towns presents challenges for the delivery of effective social services.

The 2011 Census data indicates that the total Aboriginal population for Western NSW is 25,021. Communities with significant Aboriginal population include Walgett (69%), Coonamble (45%), Brewarrina (40%), and Bourke (33%).

The 2011 ABS Census shows that there were 676 homeless people in Western NSW which represented 2% of the total homeless population in NSW on the Census night. The District overall experiences significant numbers of domestic violence incidents, with 1,828 domestic violence-related Apprehended Violence Orders issued by the NSW Courts in 2013 (source: NSW Bureau of Crime Statistics and Research).

The NPAH funds a significant homelessness response for young people and clients experiencing domestic and family violence in the Western NSW District, including:

Targeted Domestic and Family Violence services

- Staying Home Leaving Violence Dubbo
- Staying Home Leaving Violence Orange

 Provision of rental subsidy for people escaping domestic and family violence (Start Safely Subsidy Program)

Targeted youth services

- Support for unaccompanied Homeless Children and Young People under 16 years (HYAP) Central West
- Support for unaccompanied Homeless Children and Young People under 16 years (HYAP) Upper Western

Other services which respond to DFV and Youth on a demand basis

Central Coast District

The Central Coast District includes the Local Government Areas of Wyong and Gosford.

The 2011 ABS Census shows there were 768 homeless people in Central Coast, which represented 3% of the total homeless population in NSW on the Census night. The rate of domestic violence related assault varies throughout the District, with a much higher rate of assault in Wyong. The District overall experiences significant numbers of domestic violence incidents, with 1050 domestic violence-related Apprehended Violence Orders issued by the NSW Courts in 2013 (source: NSW Bureau of Crime Statistics and Research).

The NPAH funds a significant homelessness response for young people and clients experiencing domestic and family violence in the Central Coast District:

- Staying Home Leaving Violence Gosford
- Staying Home Leaving Violence Wyong
- Provision of rental subsidy for people escaping domestic and family violence (Start Safely Subsidy Program)

5. Broadly, what level of NPAH funding does NSW expect to allocate to domestic and family violence, and youth homelessness in 2017-18

In 2017-18 the level of total Commonwealth and State funding allocated to DFV and youth is \$32,561,746 or 54% of the matched pool of 2017-18 funding. This includes \$18,422,934 or 30% of the matched pool for DFV and \$14,138,812 or 23% of the total pool for youth homelessness. The amounts attributed to DFV and youth do not include state-wide programs, such as Temporary Accommodation, Link2home, Private Rental Market Assistance and subsidies, as these are demand driven.

6. What is the expected level of homelessness service delivery expenditure for NSW under the NPAH in 2017-18?

2017-18: \$69,890,301
