Purpose	This Schedule supports the <i>Biosecurity (Human Biosecurity Emergency) (Human Coronavirus with Pandemic Potential) (Emergency Requirements for Remote Communities) Determination 2020</i> (the Determination) by reimbursing limited costs associated with self-isolation facilities to the states and territories (the States) covered by the Remote Travel Restrictions (RTRs), specifically the Northern Territory (NT), Western Australia (WA), South Australia (SA) and Queensland (Qld). Other jurisdictions were not included in the Determination and are not covered by this Schedule.

The Commonwealth will reimburse 50 per cent of costs related to accommodation, food and safe transport to and from facilities in WA, SA and up to 50 per cent of costs related to accommodation, food and safe transport to and from facilities in Qld.</p> <p>Payments made under this Schedule are a one-off payment based on agreed costs that have been incurred by the states during the period the Determination was in place in each jurisdiction.</p>
