STATE / TERRITORY IMPLEMENTATION PLAN - 2009-10

Context

On 7 February 2009 Victoria experienced a series of bushfires which exhibited extreme fire behaviour. The fires led to the deaths of 173 people, about 430,000 hectares of land were burnt, along with 2000 properties and 61 businesses. Entire towns were destroyed and around 78 communities were affected.

In response to those events, the Victorian Government established a Royal Commission to investigate the causes of, preparation for, responses to, and the impact on infrastructure of the fires. Simultaneously it invested significant funding to support its emergency services agencies and specific projects and initiatives to prepare the community for an expected as bad, if not worse bushfire season in 2009-2010.

The Government has determined that bushfire preparation is the top emergency management priority for NDRP projects for 2009-2010.

The projects in the implementation plan are directed to the following priorities

- community support and enhance community safety by providing key information and emergency warnings to residents and visitors
- continued support to municipal councils to maintain fire access roads, particularly in areas of high bushfire risk

Outcome / Objectives

The projects below are directed specifically to strengthen community resilience to bushfires, reduce the risk of bushfires and enhance emergency management capability and capacity to take effect before or during the coming bushfire season.

This list of outputs differs from the draft submitted earlier. The proposed project on Fire Danger Rating Indicator Boards will not be proceeding. A submission in relation to allocation of the amount of \$800,000 to one or more project will be made as soon as possible.

Administration Arrangements

The Office of the Emergency Services Commissioner (OESC) of the Department of Justice (DoJ) will work in partnership with Country Fire Authority (CFA) and its partners to implement the projects.

Risk Assessment

Victoria is conscious of the requirement under clause 15(c) in the NPA of the need to produce a state/territory-wide risk assessment in accordance with the relevant Australian standards.

In 2008, Victoria's State Emergency Mitigation Committee undertook a state-level, statewide emergency risk assessment that included assessment of a range of natural disaster risks.

From it, priorities can be derived in terms of the highest priority emergency risks to Victoria. These can be deemed to be priorities for the purposes of the NDRP. A report on the risk assessment will be submitted early in 2010.

Accordingly, Victoria is not applying for Commonwealth support of \$150,000 towards a risk assessment in 2009-10 (under clause 28 of the NPA) but may include such a project in a later round of the NDRP.

Reporting and Evaluation

DoJ will submit quarterly progress reports to evaluate the progress of its two project under NDRP. With regards to the CFA project Fire Access Roads Subsidy Scheme, the same templates and reports as used under the Bushfire Mitigation Program (BMP) will be used to fulfil the reporting requirements.

In relation to the pre-2009 legacy projects, all are former NDMP projects and will be reported upon using the standard NDMP-style reporting. Responsible agencies are expected to finalise the outstanding NDMP projects listed at Attachment A by 31 December 2011.
