Managing Established Pest Animals and Weeds – Queensland

PROJECT AGREEMENT FOR MANAGING ESTABLISHED PEST ANIMALS AND WEEDS

- 1. This schedule has been developed in accordance with clause 13 of the Project Agreement for Managing Established Pest Animals and Weeds. It amends the previous Schedule C which was finalised on 16 May 2016.
- 2. The following agreed projects will be delivered by Queensland in accordance with project proposals:
 - (a) Project 1 Training in best practice pest management. This project will build increased landholder skills and knowledge in the safe handling, storage and transport of chemicals and toxins for pest animal management, as well as understanding of the latest toxins, baits and bait deployment devices. Best practice training will be delivered across eight industry sectors.

(b) Project 2 – Building skills and capacity in tramp ant management in Northern Queensland. This project will build the skills and capabilities amongst landholders and key agricultural and industry organisations to undertake detection, early intervention and management of tramp ants, including yellow crazy ant, in North Queensland. Additional activities to be undertaken in 2018-19 includes engaging a registered training organisation to continue delivery of training to local government authorities, canegrowers, developers and civil contractors and raw material businesses for surveillance, monitoring and treatment and trialling of invasive ant specific competency-based training packages with relevant stakeholder groups.
