PROJECT AGREEMENT FOR PEST ANIMAL AND WEED MANAGEMENT IN DROUGHT-AFFECTED AREAS

PART 1 - PROJECTS

- B1 The Commonwealth will contribute to NSW Local Land Services' prioritised pest and weed programs, which will help manage pest animals and weeds in drought-affected areas.
- B2 Activities will include:
 - i. infrastructure projects including:
 - cluster fencing;
 - 2. total grazing pressure fencing; and
 - 3. water-point traps.
 - ii. strategic projects for vertebrate pest and weed management including:
 - 1. baiting;
 - 2. shooting;
 - 3. toxin injectors;
 - 4. traps; and
 - 5. the use of remote cameras for monitoring and optimising pest control.
 - iii. emerging issues projects that address pest animals and weeds that have the potential to have an increasing impact on production including:
 - 1. control of Boxthorn in the Western division;
 - 2. exclusion fencing and traps for the control of feral deer populations; and
 - 3. local eradication of isolated large feral herbivore populations (feral donkeys, deer and camels).
- B3 Funding will be targeted to areas NSW considers to be most in need (i.e. long-term drought-affected areas), including Central Tablelands, Central West, Hunter, Murray, North Coast, North West, Northern Tablelands, Riverina, South East and Western.
