# NATIONAL PARTNERSHIP AGREEMENT ON THE PILOT OF DROUGHF REFORM MEASURES IN VESTERN AUSTRALIA

# National Partnership Agreement on the Pilot of Drought Reform Measures in Western Australia

INTERGOVERNMENTAL AGREEMENT ON FEDERAL FINANCIAL RELATIONS

#### PRELIMINARIES

- 1. This National Partnership Agreement (the Agreement) is created subject to the provisions of the Intergovernmental Agreement on Federal Financial Relations and should be read in conjunction with that Agreement and subsidiary schedules. In particular, the schedules include direction in respect of performance reporting and payment arrangements.
- 2. This Agreement has been established to enable the Commonwealth Government and Western Australian Government to implement a pilot of drought reform measures. The aim of the pilot is to assess the effectiveness and efficiency of possible alternative mechanisms, practices and delivery arrangements for drought relief, increasing farmers' preparedness to manage the impacts of increased climate variability, and the effects on agriculture-dependent rural communities.
- 3. This Agreement will be implemented consistent with the objectives and outcomes of all National Agreements and National Partnerships agreed by the Parties. In particular, the Parties are committed to addressing the issue of social inclusion, including responding to Indigenous disadvantage (for example, the reform commitments provided in the National Indigenous Reform Agreement) and those commitments are embodied in the objectives and outcomes of this Agreement.

## PART 1 — FORMALITIES

#### Parties to this Agreement

4. In entering this Agreement, the Commonwealth Government and the Western Australian Government recognise that they have a mutual interest in supporting farmers and rural communities to prepare for drought, impacts of increased climate variability and other challenges, and that they need to work together to achieve these outcomes.

#### Term of the Agreement

5. This Agreement commenced in May 2010 on signing of the original agreement by the Commonwealth Government and Western Australian Government. This Agreement was varied by the Parties on 31 October 2011 and will expire on 30 June 2014, unless terminated earlier or extended as agreed in writing by the Parties.

6. Programs included in this Agreement will cease on 30 June 2012. However, payments for the Building Farm Businesses program will cease by 30 June 2014.

### Enforceability of the Agreement

7. The Parties do not intend any of the provisions of this Agreement to be legally enforceable. However, that does not lessen the Parties' commitment to the Agreement.

#### Delegations

- 8. The Commonwealth Minister for Agriculture, Fisheries and Forestry is authorised to agree or amend Schedules to this Agreement on behalf of the Commonwealth.
- 9. The Western Australian Minister for Food and Agriculture is authorised to agree or amend Schedules, to this Agreement on behalf of the Western Australian Government.

## PART 2 — OBJECTIVES, OUTCOMES AND OUTPUIS

#### Objective

10. Through this Agreement, the Parties aspire to enhance their understanding of potential measures that will increase the resilience and capacity of farmers, farming families and their communities to better prepare for and self-manage drought, climatic variability and reduced water availability.

#### Outcomes

- 11. This Agreement will facilitate future government consideration of more effective and efficient policy measures that seek to achieve the following outcomes:
  - (a) farmers and farm families that can better adapt and adjust to the impacts of drought, increased climate variability and reduced water availability;
  - (b) a more effective social support system for farming families and communities;
  - (c) farmers are encouraged to adopt self-reliant approaches to managing farm risks; and
  - (d) farmers are encouraged to more sustainably and efficiently use Australia's natural resource base and water resources.

#### Outputs

- 12. The objectives and outcomes of this Agreement will be achieved by implementation and delivery of programs in a defined region of Western Australia (as outlined in Schedule B), including the provision of:
  - (a) training to enhance farmers' skills in strategic business planning;
  - (b) grants that improve the capacity of farm businesses to prepare for and adjust to drought and a changing climate and contribute to natural resource management outcomes;
  - (c) support to rural communities to build social capital and enhance community networks;

Intergovernmental Agreement on Federal Financial Relations

- (d) income support to farmers facing financial hardship;
- (e) enhanced and better coordinated social support network; and
- (f) support to farmers exiting the industry, or considering their options other than farming.
- 13. The pilot of drought reform measures will occur in a defined region of Western Australia as described in Schedule B.

#### PART 3 — ROLES AND RESPONSIBILITIES OF EACH PARTY

14. To realise the objectives and commitments in this Agreement, each Party has specific roles and responsibilities, as outlined below.

#### Role of the Commonwealth Government

- 15. The Commonwealth agrees to be accountable for the following roles and responsibilities and will:
  - (a) fund and deliver the following pilot programs under this Agreement:
    - 1 Farm Family Support provide income support to farmers facing financial hardship to allow them to meet basic household expenses and to assist them to understand better and take action to improve the financial position of their households.
    - 2 Stronger Rural Communities in 2010-11 provide support to assist rural communities facing significant agriculture-related hardship to build social capital and community networks, and to encourage participation in social networks and community events, in accordance with Attachment A of Schedule E.
    - 3 Farm Social Support deliver an enhanced and better coordinated social support network to meet the mental health, counselling and social needs of farming families and rural communities.
    - 4 Beyond Farming provide opportunities for farmers to engage with ex-farmers on the opportunities available outside of farming.
    - 5 Farm Exit Support provide opportunities for farmers with low assets who are having difficulty adjusting their farm businesses to the challenges of Australia's variable climate to make a dignified exit from farming;
  - (b) jointly fund grants paid to farmers through the Building Farm Businesses program, under this Agreement, in accordance with Schedule D;
  - (c) provide a financial contribution to support the implementation of this Agreement; and
  - (d) conduct a review of the pilot in accordance with Terms of Reference agreed between the Commonwealth and Western Australian Governments.

#### Role of the Western Australian Government

- 16. The Western Australian Government agrees to be accountable for the following roles and responsibilities:
  - (a) fund and deliver the Farm Planning program in accordance with Schedule C;
  - (b) jointly fund and deliver grants paid to farmers through the Building Farm Businesses program with the Commonwealth Government in accordance with Schedule D;
    - 1 in 2011-12 fund and deliver the Stronger Rural Communities program through the provision of a suite of community support measures in accordance with Attachment A of Schedule E.
  - (c) report on the delivery of measures as set out in Part 4 Performance Reporting;
  - (d) not submit an Exceptional Circumstances application to the Commonwealth Government for any area within the defined pilot region from the commencement of the Agreement until 31 March 2012. Any subsequent successful application will not take effect until 1 July 2012 at the earliest;
  - (e) provide a financial contribution to support the implementation of this Agreement; and
  - (f) ensure that prior agreement is reached with the Commonwealth on the nature and content of any events, announcements, promotional material or publicity relating to activities, and that the roles of both Parties will be acknowledged and recognised appropriately.

#### Role of the Pilot of Drought Reform Measures Working Group

- 17. The Pilot of Drought Reform Measures Working Group (Working Group) will coordinate the implementation of this Agreement.
- 18. The representatives and function of the Working Group are set out in Schedule A.

#### PART 4 — PERFORMANCE REPORTING

- 19. The Parties will produce monthly/ongoing reports to provide data and information on the uptake of the programs. These will be provided to the Working Group to:
  - (a) enable monitoring of the delivery and outputs of programs;
  - (b) ensure communication activities are well targeted; and
  - (c) assess estimated financial contributions.
- 20. These data and information will contribute to the review of the pilot.

## PART 5 — FINANCIAL ARRANGEMENTS

#### Financial contributions

21. The Commonwealth will provide a financial contribution to the Western Australian Government in respect of grants paid to farmers under the Building Farm Businesses program outlined in Schedule D.

#### GOVERNMENT-IN-CONFIDENCE

#### Intergovernmental Agreement on Federal Financial Relations

- 22. The Commonwealth's financial contribution will not be reduced where the Western Australian Government secures funding from other activity partners through innovative and collaborative partnerships.
- 23. The Western Australian Government's financial contribution to the total costs of the pilot will be \$13.31 million as contributions toward the funding of the Farm Planning program, the Building Farm Businesses program and the Stronger Rural Communities measures and whatever additional financial or in-kind resources it requires to deliver these programs.
- 24. The Commonwealth and the Western Australian Government's estimated financial contribution to the operation of this Agreement, including through National Partnership payments to Western Australia are shown in Table 1.

Notes: Table 1 does not include the additional financial or in-kind resources provided by the Commonwealth and WA Governments for delivery of the pilot programs.

- 25. National Partnership payments to Western Australia will be paid in accordance with *Schedule D* — *Payment Arrangements* of the Intergovernmental Agreement on Federal Financial Relations.
- 26. Having regard to the agreed estimated costs of projects specified, the Western Australian Government will not be required to pay a refund to the Commonwealth if the actual cost of the project is less than the agreed estimated cost of the project. Similarly, the Western Australian Government bears all risk (for their measures) should the costs of a project exceed the agreed estimated costs. The Parties acknowledge that this arrangement provides the maximum incentives for Western Australia to deliver projects cost effectively and efficiently.

## PART 6 — GOVERNANCE ARRANGEMENTS

#### **Dispute resolution**

- 27. Any Party may give notice to other Parties of a dispute under this Agreement.
- 28. The Pilot of Drought Reform Measures Working Group will attempt to resolve any dispute in the first instance. If a dispute cannot be resolved by the Pilot of Drought Reform Measures Working Group, it may be referred by a Party to the relevant Ministers.
- 29. If a dispute cannot be resolved by the relevant Ministers, it may be referred by a Party to the Council of Australian Governments for consideration.

#### **Review of the Agreement**

- 30. The Agreement will be reviewed by 17 December 2010 and by 30 March 2012 with regard to progress made by the Parties in respect of achieving the agreed outcomes and to the allocation of financial contributions if actual demand is significantly different to estimated demand.
- 31. The Agreement will be reviewed by 30 November 2011 to assess progress made by Parties in respect of achieving the agreed outcomes, objectives and outputs.

#### Variation of the Agreement

- 32. The Agreement may be amended at any time by agreement in writing by all the Parties.
- 33. A Party to the Agreement may terminate their participation in the Agreement at any time by notifying all the other Parties in writing.

## Pilot of Drought Reform Measures Working Group

- A1. The Pilot of Drought Reform Measures Working Group (the Working Group) consists of representatives from:
  - (a) Australian Government Department of Agriculture, Fisheries and Forestry (Chair);
  - (b) Department of Agriculture and Food Western Australia;
  - (c) Australian Government Department of Health and Ageing;
  - (d) Australian Government Department of Human Services;
  - (e) Australian Government Department of Families, Housing, Community Services and Indigenous Affairs; and
  - (f) Centrelink.
- A2. The functions of the Working Group will be settled in writing between the Secretary of the Department of Agriculture, Fisheries and Forestry and the Director-General of the Department of Agriculture and Food Western Australia but are expected to include:
  - (a) coordinating the implementation of the pilot;
  - (b) monitoring progress of programs and activities carried out under this Agreement;
  - (c) assessing the distribution of financial contributions if actual demand for the measures is significantly different to estimated demand; and
  - (d) overseeing the review of the pilot.
- A3. Unless otherwise agreed the Working Group will:
  - (a) meet quarterly or as required; and
  - (b) be chaired by the Australian Government Department of Agriculture, Fisheries and Forestry.

## Farm Planning

- C1 The Farm Planning program aims to:
  - (a) enhance farmers' skills in business, natural resource management and personal planning with a particular focus on managing drought and climate variability; and
  - (b) increase the number of farm enterprises with comprehensive written strategic business plans.

The program will be delivered through a training program structured around strategic business planning and will include an independent assessment that the implementation of the plan would lead to a more viable farm enterprise.

- C2 Completion of the Farm Planning program is a prerequisite for eligibility for the Building Farm Businesses program (see Schedule D).
- C3 The program will be funded and delivered by the Western Australian Government. For the 2010-11 delivery year, \$7,500 will be available, to provide each eligible farm enterprise in the pilot region, consisting of:
  - (a) up to \$6,500 per farm enterprise to an endorsed service provider for the delivery of training and advice for the development of a strategic business plan. Within this amount, up to \$2,500 is to offset the cost of developing the financial components of the strategic business plan, including an independent assessment that the implementation of the plan would lead to a more viable farm enterprise; and
  - (b) up to \$1,000 per farm enterprise, paid by reimbursement, to offset the cost of attendance (travel, accommodation, childcare costs).

For the 2011-12 delivery year, the Western Australian Government will fund this measure as necessary to achieve Pilot objectives, and in doing so will expend a minimum of \$7,500 per farm enterprise as indicated by (a) and (b) above.

#### Role of the Commonwealth

- C6 The Commonwealth, represented by DAFF, will have responsibility for:
  - (a) ensuring that DAFWA is fully aware of links with other measures in the Pilot of Drought Reform Measures in Western Australia, in particular with the Building Farm Businesses program;
  - (b) consulting with DAFWA on the development and implementation of the program; and
  - (c) providing clarification and advice on any matters relating to overall policy intent.

#### Role of the Western Australian Government

- C7 The Western Australian Government, represented by the DAFWA, will have responsibility for:
  - (a) providing opportunity for farmers in the Western Australian pilot region to participate in the Farm Planning program;
  - (b) ensuring that training opportunities provided in the Western Australian pilot region are appropriately spread across the region and over time, to account for farmers' potential availability to attend and to facilitate the implementation of the Building Farm Businesses program;
  - (c) ensuring that the training under Farm Planning is structured on strategic business planning that covers the social, economic and environmental/physical components of the farm business;

- (d) consulting with DAFF on the development and implementation of the program including key learning outcomes, processes for the recognition of prior learning and the assessment of viability;
- (e) ensuring training providers are appropriately qualified to deliver management level training consistent with the Australian Qualifications Framework used in the Vocational and Technical Education sector;
- (f) developing, in consultation with DAFF, Program Guidelines and making these public before commencement of the program;
- (g) administering the program within an appropriate governance framework including an appeal mechanism and verification and auditing processes; and
- (h) reporting on the program to the Working Group.

#### Performance Measures

- C8 DAFWA, as the entity responsible for the Farm Planning program, will collect and make available to the Commonwealth data on key performance measures to inform the review of the pilot. Information will be collected from participants and DAFWA records under the following categories:
  - (a) level of interest in the program;
  - (b) accessibility of the program;
  - (c) compliance with program requirements;
  - (d) administrative efficiency;
  - (e) program expenditure;
  - (f) stakeholder feedback; and
  - (g) preliminary outcomes (e.g. proportion of attendees who intend to act on their strategic business plan).

## **Building Farm Businesses**

#### Description

- D1 Building Farm Businesses is a grants program that assists eligible farm enterprises to meet the cost of completing activities to prepare for and reduce the impacts of drought, reduced water availability and increased climate variability on agricultural productivity and the farm enterprise.
- D2 Building Farm Businesses aims to:
  - (a) assist eligible farm enterprises to adjust their business, improve risk management and improve their capacity to prepare for drought, reduced water availability and the impacts of increased climate variability;
  - (b) increase natural resource management efforts to improve on-farm resilience and reduce the environmental impact of agricultural activity in times of extreme climatic conditions, such as drought; and
  - (c) reduce human stress associated with drought and reduce reliance on in-drought assistance.
- D3 There are two grants under the Building Farm Businesses program:
  - (a) Farm Business Adaptation Grants are available for eligible activities that help farm enterprises to prepare for drought, reduced water availability and the impacts of increased climate variability; and
  - (b) Landcare Adaptation Grants are available for eligible activities with a natural resource management focus that help farm enterprises to prepare for drought, reduced water availability and the impacts of increased climate variability, confer a broader public benefit in relation to natural resource management and are consistent with national and state natural resource management priorities.
  - (c) Applications can be made for either one or both grants. However, the total funding per farm enterprise under Building Farm Businesses is capped at \$60,000 (GST exclusive) in 2010-11 and \$30,000 (GST exclusive) in 2011-12.
- D4 Farm enterprises will not be eligible for Exceptional Circumstances Interest Rate Subsidies in any financial year in which they have accessed or will access Building Farm Businesses program funding.

- D7 Expenditure under this National Partnership will be cost-shared between the Commonwealth and Western Australia as follows:.
  - (a) For grant applications between 1 July 2010 to 31 May 2011 for every \$1,000 paid to farmers under the program, the Commonwealth government will contribute \$890 and Western Australian government will contribute \$110 respectively.
  - (b) For grant applications between 1 July 2011 to 31 May 2012 for every \$1,000 paid to farmers under the program will be borne solely by the Commonwealth.
  - (c) Costs associated with the administration of this program are the responsibility of the Western Australian government and are outside these funding arrangements.

- D8 Payments by the Commonwealth to Western Australia will be conditional on the acceptance of a report by the Commonwealth Department of Agriculture, Fisheries and Forestry from the Department of Agriculture and Food Western Australia, which sets out:
  - (a) Commonwealth funds received to date;
  - (b) Western Australian funds contributed to date;
  - (c) funds paid to successful grant applicants; and
  - (d) Commonwealth funding required to reimburse Western Australia for the Commonwealth's share of the grants paid to farmers under the program.

#### Role of the Commonwealth

- D9 The Commonwealth, represented by the Department of Agriculture Fisheries and Forestry, will have responsibility for:
  - (a) ensuring that the Western Australian Government is fully aware of related measures in the pilot of drought reform measures in Western Australia;
  - (b) providing clarification and advice on any matters relating to overall policy intent; and
  - (c) jointly approving the program's grant guidelines.

#### Role of the Western Australian Government

- D10 The Western Australian Government, represented by the Department of Agriculture and Food Western Australia, will have responsibility for delivery of the Building Farm Businesses program in the Western Australia pilot region, including:
  - (a) jointly approving the program's grant guidelines;
  - (b) assessing all grant applications against Grant Guidelines agreed by the Commonwealth and the Western Australian Government and seeking advice, as necessary, to ensure that the purpose of the grant has been substantiated;
  - (c) developing arrangements for the efficient administration and timely transfer of funds to successful grant applicants, including financial, contractual and reporting arrangements;
  - (d) ensuring a fair and equitable complaints and appeals process for grant applicants; and
  - (e) reporting on the program to the Pilot of Drought Reform Measures Working Group.

#### Performance Measures

D11 DAFWA, as the entity responsible for administering the Building Farm Businesses program, will collect and make available to the Commonwealth data on key performance measures to inform the review of the pilot. Data will be collected from participants and DAFWA records, including on the following:

- (a) level of interest in the program;
- (b) accessibility of the program;
- (c) compliance with program requirements;
- (d) administrative efficiency;
- (e) program expenditure;
- (f) stakeholder feedback; and
