# Appendix A – In-scope activities

## In-scope:

- Advice from consultants and work undertaken in which the Commonwealth has an interest;
- Advice from consultants in support of the candidature;
- Updated implementation plan including project timeline, key deliverables, responsibilities and budget;
- Guarantees and Olympic Host Contract;
- Response to the Future Host Questionnaire and associated documents; and
- Preparation of documentation in support of the candidature.

## Out of scope:

- Costs for services to support the delivery of Queensland's responsibilities in support of the candidature, including the provision of legal advice or work undertaken on behalf of the state.

Note: The candidature period is defined as commencing 1 December 2019 upon announcement of Australia entering the 'Continuous Dialogue' phase with the International Olympic Committee. The candidature period for consideration of activities to provide payment within the 2020-21 financial year must be complete by 15 May 2021 for assessment by the Commonwealth under this Schedule.
