# NATIONAL PARINERSHIP AGREEMENT ON PRODUCTIVITY PLACES PROGRAM

# National Partnership Agreement on Productivity Places Program

### PRETTY NARTES

- 1. The Productivity Places Program is part of the Commonwealth Government's Skilling Australia for the Future initiative and aims to reduce skills shortages and increase the productivity of industry and enterprises. All governments are committed to increasing investment in training and ensuring this is targeted to address areas of skills shortages across the Australian economy.
- 2. The National Partnership Agreement for Productivity Places (the Agreement) is a component of the Productivity Places Program.
- 3. This Agreement will contribute to meeting the objectives and outcomes identified in the National Agreement for Skills and Workforce Development.
- 4. Where States or a territory agrees to move to an entitlement-based student demand driven system, the Commonwealth may consider treating Productivity Places Program funding in a similar way as Specific Purpose Payment base funding for the purposes of accountability and reporting.

### PART 1 — FORMALITIES

### Parties to this Agreement

5. In entering this Agreement, all parties aim to increase the number of people with qualifications and the number of people with higher level qualifications.

### Term of the Agreement

- 6. This Agreement is created subject to the provisions of the *Intergovernmental Agreement on Federal Financial Relations* and its schedules, and should be read in conjunction with them.
- 7. This Agreement will commence on 1 January 2009 and will expire on 30 June 2012, or earlier, if termination is agreed in writing by the Parties.
- 8. The Commonwealth and State and Territory Governments undertake to honour their commitment to existing workers and job seekers who enrolled during the life of this Agreement but did not complete their qualification by 30 June 2012.

### **Delegations**

9. The Commonwealth Minister for Education is authorised to agree to the Implementation Plan on behalf of the Commonwealth and certify that payments may be made to the States and

Territories on the achievement of performance benchmarks specified in the Implementation Plan.

10. Ministers responsible for Vocational and Technical Education or their equivalents are authorised to agree the Implementation Plan on behalf of their State or Territory.

### Interpretation

- 11. Unless otherwise specified, the following terms and definitions are used throughout the Agreement:
  - (a) Qualification commencement refers to a new enrolment in a qualification as defined by the Australian Vocational Education and Training Management Information Statistical Standard (AVETMISS).
  - (b) Course enrolment includes both new enrolments and continuing enrolments in a qualification as defined by AVETMISS.
  - (c) Training Place refers to a quantum of training funding which varies by qualification level and is available in respect of a vocational education and training student on an annual basis. The number of places required to complete a qualification varies across Australian Qualification Framework levels. Two places are allocated to complete a Certificate II, Certificate III and Certificate IV and three places for a Diploma and Advanced Diploma.
  - (d) Private contribution refers to the financial contribution of an enterprise or an individual towards the cost of delivering a course enrolment.
  - (e) Government contribution refers to the financial contribution of the Commonwealth, State and Territory Governments towards the cost of delivering a course enrolment.
  - (f) Job seeker refers to someone who is:
    - (i) registered with an Employment Service Provider (ESP); or
    - (ii) an income support recipient who is not currently required to meet activity test or participation requirements; or
    - (iii) a participant in the Community Development Employment Projects scheme; or
    - (iv) not currently working and seeking or intending to seek paid employment or self employment after completing the qualification; or
    - (v) a participant in the Commonwealth's Access Program; or
    - (vi) not working and participating in volunteering activities.

- (g) Existing worker refers to someone who in the previous week worked for one hour or more for pay, profit, commission, or payment in kind. This definition excludes those people who may work for more than one hour per week but are particularly disadvantaged<sup>1</sup> in the labour market.
- (h) National qualification profile refers to the target number of qualifications for each level of qualification that will be available under the Agreement. The national target qualification profile is:
  - (i) two thirds of job seeker places at a minimum of Certificate III level;
  - (ii) 50 per cent of existing worker places at Diploma and Advanced Diploma level; and
  - (iii) 40 per cent of existing worker places at Certificate IV level.
- (i) National priority list refers to national priority industries, occupations and qualifications in areas of current skills shortages and emerging skills needs that the Commonwealth is proposing to target under the Agreement.
- (j) Skills Australia is a new independent statutory body that has been established to provide advice to the Commonwealth Government on current and future demand for skills and investment of public funds in training, including identification of priority occupations and qualifications for the Productivity Places Program at the national level

### PART 2 — OBJECTIVES, OUTCOMES AND OUTPUTS

### Objectives and outcomes

12. The implementation of the Agreement will assist in meeting the objectives and outcomes identified in the National Agreement on Skills and Workforce Development.

### **Outputs**

- 13. The Agreement has two outputs: qualification commencements and course enrolments. Through the Agreement, 557,556 course enrolments and 402,881 qualification commencements will be delivered.
- 14. The output components of the agreement are detailed in Table 1.

Particularly disadvantaged in this context means: an income support recipient who is not currently required to meet activity tests or participation requirements or a participant in the Community Development Employment Projects scheme.

### PART 3 - ROLES AND RESPONSIBILITIES OF EACH PARTY

15. To realise the objectives and commitments in this Agreement, each Party has specific roles and responsibilities, as outlined below.

### Role of the Commonwealth

- 16. The Commonwealth will have responsibility for:
  - (a) providing data and information to Skills Australia to assist it in identifying industries, occupations and regions that are experiencing skills shortages;
  - (b) establishing the national priority list based on advice, including from Skills Australia;
  - (c) ensuring national ISCs work in partnership with State Training Authorities and State and Territory industry advisory bodies in order that information and advice is provided to Skills Australia in regard to industries, occupations and qualifications that are experiencing current and emerging skills shortages;
  - (d) engaging in bilateral discussions with States and Territories on a biannual basis to obtain agreement on the priority industries, occupations and qualifications that will be targeted under the Agreement in each State;
  - (e) approving State and Territory implementation plans;
  - (f) working with States and Territories to develop a national data portal by 2012 for all government funded training delivery which encompasses AVETMISS reporting requirements and allows for the tracking of individual students;
  - (g) compiling a comprehensive annual report, in consultation with States and Territory Governments that details the achievements in the delivery of training against State and Territory industry, occupation and qualification targets;
  - (h) working with States and Territories to make data on training activity under the Agreement available to the public;

At its July meeting, COAG received advice from Skills Australia on the possible allocation of up to 50,000 additional vocational education and training places for areas of national skills shortage in health occupations. 4,500 of these qualifications were made available from 31 July 2008 to 31 December 2008.

- (i) making available to States the Productivity Places Program Information Management System (PIMS) and managing the database; and
- (j) developing communication protocols for the Agreement in consultation with States and Territories.

### Role of the States and Territories

17. The States and Territories will have responsibility for managing and implementing the Agreement.

### PART 4 — PERFORMANCE BENCHMARKS AND REPORTING

### Implementation plan

- 18. State and Territories entering into the Agreement will be required to develop an implementation plan, in accordance with the template in Appendix B, which demonstrates how they will manage and implement the Agreement and meet the conditions of this part of the Agreement.
- 19. This implementation plan is to be provided to the Commonwealth for approval by 12 December 2008.

### Outputs and funding

- 20. The States and Territories will:
  - (a) ensure all outputs are in addition to current effort;
  - (b) ensure access to the training available under the Agreement is limited to people aged 15 years<sup>3</sup> or over who are:
    - (i) Australian citizens; or
    - (ii) Permanent residents of Australia<sup>4</sup>; or
    - (iii) Humanitarian refugees.
  - (c) ensure access to the training available under the Agreement is limited to those who fit the definitions at 1.2.3 of this Agreement;
  - (d) target outputs to the areas of current skills shortages and emerging skills needs agreed under the arrangements outlined in the 'Management and Implementation' section of the Agreement;
  - (e) encourage training providers participating in the Agreement to provide flexible delivery options (for example part-time outside business hours in workplaces and catering for people with a disability) to meet the diverse learning and cultural needs of participants in a range of geographical locations.

Or the legislated minimum State or Territory school leaving age in States and Territories where it is higher than 15 years of

- (f) subject to the arrangements in the 'Management and Implementation' section of the Agreement, distribute total outputs in line with the relevant nominal allocation in Appendix A Tables 1-7;
- (g) subject to the arrangements in the 'Management and Implementation' section of the Agreement, provide funding as per the nominal allocation in Appendix A, Tables 1-7;
- (h) put in place arrangements to ensure that the minimum 10 per cent private contribution is levied in aggregate for training of existing workers;
- (i) implement protocols including financial arrangements to govern the administrative arrangements for national enterprises operating in more than one jurisdiction to ensure that they only have to deal with one point of contact to arrange cross jurisdictional delivery of training; and
- (j) ensure funding is used for payments to Registered Training Organisations for the provision of training only and not for administration of the Agreement.<sup>5</sup>

### Reporting

- 21. Reporting under this National Partnership will comply with the requirements of Schedule C to the *Intergovernmental Agreement on Federal Financial Relations*.
- 22. In the long term, States and Territories will use a national data portal to track individual students when such a data portal encompasses all AVETMISS reporting requirements and is available to capture all publicly funded delivery. States and Territories agree to work towards implementing the required changes to AVETMISS to enable these changes to be applied to activity from 2012 at the latest.
- 23. Prior to the establishment of the national data portal:
  - (a) Reporting on the Agreement will occur through AVETMISS and States and Territories, in conjunction with the Commonwealth, will consult with the National Centre for Vocational Education and Research (NCVER) on the changes required to the collection. These changes will apply to activity from 1 January 2009.
  - (b) If these changes can not be applied to activity from 1 January 2009, States and Territories will collect and report on the additional data fields which sit outside AVETMISS and are required by the Commonwealth, until the changes to AVETMISS can be applied to activity under the Agreement.
  - (c) States and Territories will determine the most appropriate approach to providing the additional data.
  - (d) Where States and Territories choose to utilise the Productivity Places Program Information Management System (PIMS) as the means for providing the additional data, the Commonwealth will continue to provide administrative funding of \$110 per student input.
- 24. States and Territories will establish appropriate mechanisms to demonstrate the additionality of outputs delivered under the Agreement to current effort.

Independently from this agreement, Heads of Treasury may determine cost-sharing arrangements between governments for the administration of election commitments.

- 25. States and Territories will demonstrate the additional outputs in aggregate over the life of the Agreement.
- 26. States and Territories will develop a trajectory over the life of the Agreement which details when the additional outputs will be delivered on an annual basis, and a monthly basis within each calendar year.
- 27. States and Territories will provide the Commonwealth with preliminary AVETMISS data reports on publicly funded training delivery for each month within seven days of the completion of that month. These reports will be for all VET activity in the previous month.
- 28. States and Territories will provide biannual reports (31 January and 31 July) which demonstrate progress against output targets and an analysis of barriers and achievements in meeting the targets.
- 29. States and Territories will report on the arrangements that were put in place to ensure that the minimum 10 per cent contribution is collected in aggregate from employers / individuals for training places allocated by that State or Territory.
- 30. States and Territories will establish and maintain separate financial reporting arrangements which may include a separate account for management of Commonwealth Government and State and Territory Government contributions for the Agreement.

### Industry and enterprise engagement and brokerage

- 31. States and Territories will:
  - (a) ensure a role for national ISCs in the brokerage of training delivered under the Agreement. Where national ISCs broker training, States and Territories will ensure clients subject to the brokerage are given priority access to training, where they meet eligibility requirements and the allocation of training has not been exhausted;
  - (b) ensure State and Territory industry advisory bodies/arrangements work in partnership with national ISCs to identify occupations and qualifications that are experiencing current and emerging skills shortages;
  - (c) provide clients with access to training where brokered by Employment Service Providers where they meet eligibility requirements and the allocation of training has not been exhausted:
  - (d) provide appropriate data and information to Skills Australia to assist it in identifying industries, occupations and regions that are experiencing skills shortages; and
  - (e) ensure all enterprises (public, private and not for profit) have fair and equitable access to the training available through the Agreement.

### **Providers**

- 32. States and Territories will ensure that competition for the provision of training is open to all private and public RTOs that meet the following conditions:
  - (a) financial viability;
  - (b) registration in relevant jurisdiction with capacity to deliver the specific qualification (have existing Scope of Registration); and
  - (c) data compliance with the AVETMISS for publicly funded training.

### Publications and communications

33. States and Territories will acknowledge the Agreement as a joint Commonwealth and State or Territory initiative in all publications, promotional and advertising materials, public announcements and activities, or any products, processes or inventions developed as a result of the implementation of the Agreement.

### Management and implementation

### Outputs and funding

- 34. As detailed in Appendix A, Tables 1-7 the Commonwealth has nominally allocated each State and Territory its working age population share of the output targets.
- 35. Additionality of outputs will be accounted for in aggregate over the life of the Agreement.
- 36. There will be bilateral negotiations between the Commonwealth and each State and Territory on five issues:
  - (a) The national priority list:
    - (i) The national priority list will be used as a starting point for negotiations on the priority occupations to be targeted in each State and Territory.
    - (ii) States and Territories may suggest that qualifications be added or removed from the national priority list for the purposes of the Agreement if there is evidence that national priorities do not reflect State/Territory or regional needs or may result in perverse outcomes<sup>6</sup>.
    - (iii) For the purpose of these bilateral negotiations, evidence of a current or emerging skills shortage constitutes a written case (supported by qualitative and/or qualitative data) that identifies the difference between the national priority list and State or Territory priorities.
  - (b) The roll out of training delivery jurisdictions will develop a trajectory of course enrolments over the life of the Agreement.
  - (c) If circumstances change there is provision for both the number of course enrolments and number of qualifications to be renegotiated through the bilateral agreement. Funding requirements will be recalculated if output targets are renegotiated.
  - (d) The potential reallocation of un-utilised training places.
  - (e) Any reconciliation issues in regards to commencements and funding arising from training under existing bilateral contracts (MOUs).
- 37. The non-Commonwealth funding contributions will be accounted for in aggregate over the life of the Agreement.
- 38. States and Territories will have the flexibility to decide how the 10 per cent private contribution is collected and the level of individual contribution.

39. States and Territories can continue to use their current fees and charges system to collect the private contribution.

### Industry and enterprise engagement and brokerage

- 40. It is acknowledged in the Commonwealths Skilling Australia for the Future policy that the national Industry Skills Councils (ISCs) will have a role in monitoring training provided under the existing worker element of the Agreement to ensure it is relevant to enterprises and meets their needs.
- 41. National ISCs working with State and Territory industry training advisory bodies will provide integrated industry intelligence to Skills Australia on skills shortages and emerging skills needs.
- 42. Skills Australia will provide advice to the Commonwealth Minister for Education on industries, occupations and qualifications where there are current and emerging skills shortages.
- 43. The advice of Skills Australia will be used by the Commonwealth Minister for Education to identify national priority industries, occupations and qualifications (the national priority list).
- 44. Under the job seeker element of the Agreement, Employment Service Providers will have a brokerage role to place disadvantaged job seekers with RTOs delivering training under the Agreement. These activities are recognised in separate contractual arrangements between the Commonwealth and Employment Services Providers.

### Performance benchmarks

45. The implementation of the Agreement will contribute to meeting the objectives of the National Agreement for Skills and Workforce Development. In addition there are some specific targets for this Agreement. These targets are identified below.

### **Performance Indicators**

46. The table below identifies the national performance indicators and targets for the Agreement. State and Territory targets for the Agreement will be identified through bilateral Agreement.

### Base and Additionality

- 47. Each jurisdiction's base for places and qualifications has been calculated using an average of AVETMISS data over three years (2005, 2006 and 2007) for qualifications within the Agreement scope Certificates II, III, IV, Diplomas and Advanced Diplomas.
- 48. The base upon which additionality will need to be demonstrated by each State and Territory is detailed in Table 3.

49. Counting of additionality will be limited to qualification levels within the Agreement scope — Certificates II, III, IV, Diplomas and Advanced Diplomas.

### PART 5 — FINANCIAL ARRANGEMENTS

### **Funding**

- 50. The Agreement requires funding contributions from the Commonwealth Government, State and Territory Governments, and a contribution sourced from individuals or enterprises.
- 51. Table 4 details the funding allocation the Commonwealth Government has set for each output by qualification level, and the flow of payments. For each payment for an existing worker, the Commonwealth will contribute 50 per cent, the State of Territory will contribute 40 per cent and the individual/enterprise will contribute a minimum of 10 per cent. The Commonwealth will contribute 100 per cent of each payment for a job seeker.

53. The Agreement includes nominal output targets by student category (job seeker and existing worker) and qualification level. The national nominal output targets and associated funding for each State and Territory are detailed in Appendix A.

### Reconciliation of Phase II (1 July to 31 December 2008) of the Agreement

54. The Commonwealth and State and Territory Governments undertake to honour their commitment to existing workers and job seekers who enrolled but did not complete qualifications from 1 April 2008 to 31 December 2008.

### Financial Reporting and Acquittal of Funds

- 55. Acquittal of funding under this NP is based on course enrolments.
- 56. On 31 January each year, State and Territory Governments will provide the Commonwealth Government with a final acquittal of Commonwealth Government and State/Territory funding over the previous 12 months under the Agreement.
- 57. The acquittal will be a detailed statement of income and expenditure for the NP funding which must include a definitive statement as to whether the financial accounts are true and fair. The

- acquittal will be accompanied by a statement that the funding was expended for the Agreement and in accordance with the conditions of the Agreement. This statement and the acquittal will be certified by the appropriate State or Territory delegate.
- 58. The Commonwealth Government funding contribution for training places that are not used will be returned to the Commonwealth Government.
- 59. The Commonwealth and States and Territories will agree on a formula to identify the quantum of funding that will need to be returned.

### PART 6 — GOVERNANCE ARRANGEMENTS

### Dispute resolution

- 60. Either party may give notice to other parties of a dispute under the Agreement:
  - (a) the Agreement managers will attempt to resolve any dispute in the first instance; and
  - (b) if this fails Ministers will discuss and attempt to resolve by mutual agreement.

### **Termination and Reduction**

- 61. The Agreement may be terminated at any time in whole or in part by mutual agreement of the parties in writing.
- 62. If the Agreement is terminated the parties will only be obliged to do the following from the date of termination:
  - (a) the Commonwealth will only be liable for:
    - (i) Payments under the payment provisions of this Agreement for those parts of the Agreement rendered before the date of termination; and
    - (ii) Any reasonable costs incurred by States and Territories and directly attributable to the termination or partial termination of this Agreement.
  - (b) States and Territories will:
    - (i) Immediately stop work as agreed;
    - (ii) Take all available steps to minimise loss resulting from the termination; and
    - (iii) Continue work on any Part of the Agreement not affected by the termination.

### Review of the Agreement

63. A review of funding or operational arrangements will occur not later than 30 June 2010.

### Variation of the Agreement

64. This Agreement may be varied by mutual agreement in writing between the parties to reflect a change in Commonwealth or State or Territory circumstances that impact on this Agreement.

# APPENDIX B - TEMPLATE FOR STATE AND TERRITORY IMPLEMENTATION PLANS

### Term of plan

- 1. This National Partnership is created subject to the provisions of the National Partnership Agreement for Productivity Places Program, and should be read in conjunction with the Agreement.
- 2. These arrangements will commence on 1 January 2009 and expire on 30 June 2012.

### Proposal

### Eligibility Criteria

- 3. Access to the training available under the Agreement is limited to people aged 15 years<sup>8</sup> or over who are:
  - (a) Australian citizens; or
  - (b) permanent residents of Australia<sup>9</sup>; or
  - (c) humanitarian refugees.
- 4. An individual is eligible for a job seeker place if he or she is:
  - (a) registered with an Employment Service Provider (ESP); or
  - (b) an income support recipient who is not currently required to meet activity test or participation requirements; or
  - (c) a participant in the Community Development Employment Projects scheme; or
  - (d) not currently working and seeking or intending to seek paid employment or self employment after completing the qualification; or
  - (e) a participant in the Commonwealth's Access Program; or
  - (f) not working and participating in volunteering activities.
- 5. Existing worker refers to someone who in the previous week worked for one hour or more for pay, profit, commission, or payment in kind. This definition excludes those people who may

work for more than one hour per week but are particularly disadvantaged<sup>10</sup> in the labour market.

### Outputs, Funding and Purchasing Arrangements

### Reconciliation of Phase II (1 July to 31 December 2008) of the Agreement

- 13. Arrangements for the allocation of places for existing workers between 1 July 2008 and 31 December 2008 have been outlined in the MoU put in place between the Commonwealth and participating States and Territories. The MoU provided funding for 50 per cent of the Commonwealth Funding allocation for Certificate II to Certificate IV level qualifications and 30 per cent of the funding allocation for Diploma and Advanced Diplomas. The remaining funding allocation per qualification will be provided through the Agreement.
- 14. This section of the implementation plan will be used to reconcile Commonwealth funding between the MoU and the NP. A reconciliation is required if:
  - (a) targets for new enrolments were not achieved; or
  - (b) Commonwealth payments for continuing enrolments that were to occur under the Agreement were brought forward to the MoU.

- 15. At the March 2008 meeting of COAG it was agreed to quarantine training places for up to 50,000 qualifications under the Agreement over the next three years for areas of national skills shortage in health occupations (COAG Health Places).
- 16. At the July 2008 meeting of COAG it was decided that up to 4 500 of these COAG Health Places would be made available from 31 July 2008 to 31 December 2008. At this time the Commonwealth Government agreed to fund fully the government contributions to the costs of this training during the period to 31 December 2008 with this additional funding contribution to be recognised in the financial arrangements for Phase III of the Agreement from 1 January 2009. The table below shows the reconciliation for these amounts.
