Implementation Plan – 2011 International Sailing Federation World Championships

NATIONAL PARTNERSHIP AGREEMENT ON HEALTH SERVICES

OBJECTIVES, OUTCOMES AND OUTPUTS

- A1 Western Australia has secured the right to host the International Sailing Federation World Championships (the Championships) in December 2011.
- A2 The Commonwealth has agreed to support Western Australia in hosting the Championships. In supporting the Championships, the Commonwealth seeks to:
 - provide legacies for the sport of sailing, including for people with a disability, through skills development and the transfer of assets purchased under this initiative once the Championships have ended;
 - promote the sport of sailing, including for people with a disability;
 - where appropriate, use the Championships as a vehicle for delivering the Commonwealth's healthy and active lifestyle messages;
 - enhance Australia's reputation as a world class host of international sporting events; and
 - showcase Australia as a tourism destination through global media coverage of the Championships.

A3 Commonwealth funding will be used for:

- The Emerging Nations Program provides opportunities for young sailors from less affluent sailing nations to come to Australia to develop their skills so that they can compete in future international sailing events.
- The purchase of race and race management equipment.
- An Officials and Volunteers Training Program provides for the training of officials and volunteers required for the Championships and the purchase of uniforms for officials and volunteers.
- The staging of a Test Event around one year prior to the Championships.
- Facilitating national and international coverage of the Championships.

National Partnership Agreement on Health Services

- Festivals and official celebrations associated with the Championships, including the
 opening and closing ceremonies, a street parade of competing nations and the
 establishment of a "public village" that will allow spectators to enjoy the onshore aspects
 of the Championships and expand their knowledge of the Championships and the sport of
 sailing.
- A national communications campaign that will raise public awareness of the Championships, the sport of sailing and, where appropriate, the Commonwealth's active and healthy living messages.
- An Environmental Program to promote the efficient use of water, carbon neutrality, reducing waste, environmentally friendly products for boat maintenance and anti-fouling, education and the adoption of strategies to protect the seabed.
- An Observer Program to educate potential bidders for future major national and international sporting events (all sports) on the processes for developing a bid through to delivering an event.
- A contribution to the direct costs incurred in staging the Championships including the provision of temporary facilities at the Championships, security, internal communications and sanctioning fees.

ROLES AND RESPONSIBILITIES

Role of the Commonwealth

A4 The Commonwealth will provide a funding contribution of up to \$8.6 million to the staging of the Championships. The Commonwealth's funding contribution will not be reduced where Western Australia secures funding from other activity partners through innovative and collaborative partnerships.

Role of Western Australia

- A5 Western Australia will be responsible for:
 - (i) the planning, administration and conduct of the Championships;
 - (ii) contributing or securing the balance of funding required to stage the Championships;
 - (iii) ensuring that the support received from the Commonwealth is acknowledged, in a form agreed by the Commonwealth, in all publications, promotional and advertising materials, public announcements, uniforms and activities, including the test event;
 - (iv) ensuring that the Commonwealth is afforded the status of sponsor for the Championships, as defined in the International Sailing Federation Agreement with the Championship organisers, and offering the Commonwealth the benefits associated with being a Sponsor;
 - (v) with the prior agreement of the Commonwealth, arranging for the disposal of assets purchased for the Championships in a manner that benefits the sport of sailing. This includes the disposal of assets for the benefit of people with a disability.

- (vi) maintaining a register of assets, and providing a copy of this register to the Commonwealth, as requested.
- (vii) reporting to the Commonwealth on the performance of the Championships, as outlined in this Implementation Plan.

PERFORMANCE BENCHMARKS AND FINANCIAL ARRANGEMENTS

Funding

- A6 The Commonwealth will provide funding as reports detailing progress towards meeting performance benchmarks are received, or after performance benchmarks have been met.
- A7 The maximum funding available to Western Australia under this Implementation Plan is set out in the following table:

 - (i) The Commonwealth will not make any payment if Western Australia cannot demonstrate that it implemented adequate and appropriate arrangements that would have achieved the relevant performance benchmark if not for those circumstances.

- A11 Western Australia will provide progress reports to the Commonwealth on the implementation of this initiative. Each report will include an assessment of progress towards meeting the Performance Benchmarks. The progress report will outline any delays or difficulties in undertaking the initiative and the strategies adopted to address them.
- A12 Each progress report will also be used to confirm and demonstrate the achievement of Performance Benchmarks when they fall due.
- A13 Each progress report will include a summary of how the Commonwealth's support for the Championships has been acknowledged. Western Australia and the Commonwealth will consult on the inclusion of relevant statistics in each progress report.
