#### PROJECT AGREEMENT FOR SMALL BUSINESS REGULATORY REFORM

#### PART 1 - PRELIMINARIES

- 1. This Schedule has been developed in accordance with clause 10 of the Agreement.
- 2. This Schedule will commence as soon as it is agreed between the Commonwealth and Queensland and expire on 30 June 2021 or on completion of agreed projects, including final performance reporting and processing of final payments against milestones.

#### PART 2 - FINANCIAL ARRANGEMENTS

3. The Commonwealth will provide an estimated financial contribution to Queensland of up to \$60.1 million in respect of this Agreement. All payments are exclusive of GST.

Dear Treasurer

As you are aware, the Queensland Government has been working closely with the Australian Government to effectively manage COVID-19 health and economic responses, including identifying and implementing a range of regulatory reforms to modernise business communications and streamline approval processes.

In addition to these initiatives, Queensland has been continuing to implement seven projects as part of its bilateral agreement with the Australian Government under the Small Business Regulatory Reform Agenda, which commenced in March 2019. I have been advised that five projects have been successfully completed, which are currently being reviewed by Commonwealth Treasury officers.

I have been informed the remaining two projects are progressing well despite the challenges posed by the COVID-19 pandemic, which constrained effective engagement with key stakeholders and diverted agencies' resources to initiatives to support businesses, workers and the community in response to the crisis.

Queensland Treasury officers have been consulting with your department on these matters over recent months. I understand you are cognisant of the particularly challenging environment in which our agencies have been striving to deliver key projects over the last 12 months in the context of the COVID-19 pandemic.

To enable Queensland to effectively deliver these two remaining projects, I am seeking minor extensions to the project completion dates, and a change to the functionality of one project, as follows:

- *Biosecurity Planning App*: an extension of the deadline from April 2021 to September 2021. The milestone, payment summary and reporting requirements would remain unchanged.
- Queensland Business Launch Pad: an extension of the deadline from April 2021 to February 2022. A minor change in project functionality for milestone 2 is also sought, while also increasing coverage from 40 per cent to 55 per cent of the population. Importantly, these changes are estimated to deliver a materially higher level of overall benefit to businesses than initially estimated.

Further details of the extensions sought by the Queensland Government are outlined in Attachment 1. I understand, based on advice from Commonwealth Treasury at officer level, that your agreement to these changes by exchange of letters would be sufficient and negate the need for any formal endorsement of a revised project agreement.

I would appreciate your favourable response to the amendments to the projects outlined to ensure Queensland can deliver these important reforms as part of our national reform agenda to promote small business growth and job creation.

### SUMMARY OF QUEENSLAND SMALL BUSINESS REGULATORY REFORM AGENDA PROJECT PROPOSALS

# PROJECT 1 - STREAMLINING START-UP AND COMPLIANCE FOR SMALL BUSINESSES

The initiative aims to deliver a customer journey-based platform for small businesses to better understand their start-up and compliance requirements. To achieve this, the initiative will integrate existing platforms and pilots with a view to disentangle and streamline the complex regulatory environment that may delay or impede businesses from starting, growing and employing.

The initiative will integrate a customer journey-based platform into the Business Queensland website (www.business.qld.gov.au) (BQ). This platform has been successfully piloted with businesses intending to start a café within the Brisbane and Logan local government areas. The technology used in the pilot, once integrated into BQ, will be extended further for the food and beverage industry and the residential construction industry. Additional platform enhancements including an account function that will house dynamic forms, automated notifications and progress tracking, streamlining the compliance obligations required of these industries. This will reduce delays for businesses starting up as well as minimise the administrative burden imposed on business.

Queensland will submit to the Commonwealth a report demonstrating completion of the project, attaching relevant documents to substantiate completion of the milestones below. Examples may include screenshots of customer journey maps or access to the online platform test environment to demonstrate that these deliverables are available to businesses.

# Milestone 1 - Integration with Business Queensland, ID authentication and smart form functionality

The State government will deliver the following features to start-ups in the food, beverage and residential construction industries in Queensland:

- Discovery of relevant state government licensing and regulations using clear guides to support prospective business owners in navigating the compliance burden
- Integrating identity authentication into the platform, allowing start-ups to manage their interactions with state government across multiple services with a single log-in
- Enable business owners to transact seamlessly with state government using smart form functionality, including form pre-fill and session save-points

This will include 40% of state government licensing and regulations covering a range of industry specific activities. The coverage of state government services will be determined through customer journey mapping and could include services such as liquor licensing, workers' compensation insurance, asbestos removal licensing, portable long service leave and trade licensing.

In addition, those businesses listed above that are located in participating local government areas (LGAs) will benefit from additional licensing and regulatory services including development permits, waste disposal licensing, advertising sign licensing and food licensing as a result of LGA input into the new online service.

For this milestone payment, participating local government areas will cover 10% of the Queensland population.

Milestone 2 - Improving the small business customer journey and expanding the platform

The State government will deliver the following features to all start-ups in the food, beverage and residential construction industries in Queensland, and expand the offering to existing businesses in those industries:

- <u>User controlled p</u>Progress tracking of applications/renewals (eg consolidated status dashboard of all applications, where technically feasible by a servicing agency or council)
- Full account functionality including <u>push-alert</u> notifications (eg <u>license renewals</u>, regulatory changes, relevant support services)
- Delegated authority/coverage of multiple businesses owned by the same individual

This will include the remaining 60% of state government licensing and regulations covering a range of industry specific activities. The added features will also be applied to the original 40% coverage of state government industry specific services in Milestone 1.

In addition, those businesses listed above that are located in participating local government areas (LGAs) will benefit from LGA input in the delivery of food, beverage and construction services.

For this milestone payment, participating local government areas will cover <u>40-at least 55</u>% of the Queensland population.

Dear Trezsurer

Thank you for your letter of 1 June 2021, originally directed to the Commonwealth Treasurer, concerning the Small Business Regulatory Reform Agenda (SBRRA). I am responding as I have been given ministerial responsibility for this program.

I wish to thank you for your ongoing work contributing to reducing regulatory burden on small businesses in Queensland. I am pleased to inform you that I have agreed to the payment of \$27 million for delivery of the Vocational Education and Training Support Program for Small Business and the Digital Food Safety Hub.

The Commonwealth notes the difficulties and challenges faced by the States from COVID-19 and that some projects were unable to be delivered according to their proposed timeframes. The Prime Minister has therefore agreed to extend the SBRRA project timeframe for an additional twelve months. Under this revised approach, please ensure you also give sufficient time for me to consider and agree to your claims for payment before 30 June 2022.

I understand there are some minor reform outcomes Queensland is unable to deliver with regards to projects 1 and 4.

I welcome the substitute reform you have proposed as a replacement. I consider that this substitute's benefits for Queensland small businesses far exceed what the original reforms would have provided.

With regard to Project 1 – Streamlining Start-Up and Compliance for Small Business, I agree to your proposed changes in the bilateral schedule's table 2: Milestones Reporting and Payment Summary and to the associated project proposal summary.

With regard to Project 4 – Biosecurity Entity Online Customer Portal, I understand Queensland requires a change to the bilateral schedule and the associated project proposal summary to be eligible for payment. I therefore propose to remove the line 'and maintenance of current cost recovery arrangements' from Table 2: Milestones, Reporting and Payment Summary in the schedule. I also propose to remove the line 'In the report to the Commonwealth, Queensland must also indicate that it has not increased cost recovery fees charged in real terms for biosecurity entity registration' from page 18 of the project proposal summary.

These amendments to the bilateral schedule will take effect upon your affirmative response.
