<b>Duration</b>	This Schedule is expected to expire on 30/June/2023.																
<b>Purpose</b>	This Schedule will support delivery of funding to the Northern Territory Government for administration of a remote stores licensing scheme in the Northern Territory. The intent of remote stores licensing is to create a regulatory environment which supports the viability of stores and increases individual store capacity to supply a sufficient range of quality produce for remote Aboriginal communities. The licensing scheme also seeks to establish and regulate operational standards for remote stores in the Northern Territory.
