Purpose	This Schedule will support the delivery of services for the Living Safe Together Intervention Program Expansion (the Program). The Program will ensure Australia’s Countering Violent Extremism (CVE) programs remain effective in an evolving threat environment by preventing or reducing the risk of people, particularly young people, radicalising to violent extremism in our cities and regions. The Program will increase reach into regional and rural Australia, building awareness of violent extremism in these communities so they can better recognise the signs that someone may be radicalising, and know how to refer them to an intervention program.
