- 3.2 The Department agrees to provide reasonable notice to the Recipient of any upcoming relevant Department prepared media releases, media engagements or anticipated media coverage relevant to the Program.

**4. Freedom of Information**

- 4.1 The state must provide the Commonwealth notice of any Freedom of Information (FOI) requests in relation to the Program.

**5. Evaluation**

- 5.1 The state agrees to participate in any evaluations of Program by the Commonwealth.
