Purpose	This Schedule will support the delivery of services by the Western Australia Police Force for the Living Safe Together Intervention Program (Program) expansion. The Program expansion will ensure Australia's Countering Violent Extremism (CVE) programs remain effective in an evolving threat environment by preventing or reducing the risk of people, particularly young people, radicalising to violent extremism in our cities and regions. The Program expansion will increase reach into regional and rural Australia, building awareness of violent extremism in these communities so they can better recognise the signs that someone may be radicalising, and know how to refer them to an intervention program.

- 3.2 In the event of any unplanned media coverage relevant to the Program and its participants, the Recipient agrees to inform the Department as soon as practicable.
- 3.3 The Commonwealth agrees to provide reasonable notice to WA of any upcoming relevant Department prepared media releases, media engagements or anticipated media coverage relevant to the Program.

### **4. Freedom of Information**

- 4.1 The state must provide the Commonwealth notice of any Freedom of Information (FOI) requests in relation to the Program.

### **5. Evaluation**

- 5.1 The state agrees to participate in any evaluations of Program by the Commonwealth.
