## PROJECT AGREEMENT FOR IMPROVING GREAT ARTESIAN BASIN DROUGHT RESILIENCE

### PART 1: PRELIMINARIES

1. This bilateral schedule to the Project Agreement for Improving Great Artesian Basin Drought Resilience should be read in conjunction with that Agreement. The Schedule has been developed in accordance with clause 11 of the Agreement.
2. This bilateral schedule to the Project Agreement for Improving Great Artesian Basin Drought Resilience provides for a State Work Plan. The State Work Plan is agreed by the Commonwealth and the Northern Territory senior officials and can be amended by the Northern Territory should both parties agree in writing.
3. A State Work Plan outlines the capital works, communication/education initiatives or studies that will constitute milestone targets for each financial year. At a minimum, the Work Plan will cover details as stipulated in clause A4 of the Project Agreement.

### PART 2: FORMALITIES

4. This Schedule will commence as soon as it is agreed between the Commonwealth and the Northern Territory and expire on 30 June 2024 or on completion of the project, including final performance reporting and processing of final payments against milestones.

### PART 3: FINANCIAL ARRANGEMENTS

5. Having completed an assessment of the proposed projects as listed in the State Work Plan in accordance with the Assessment Guidelines and Project Eligibility Criteria contained in Appendix A of the Agreement, the Commonwealth will provide a maximum financial contribution of 0.3m to the State for projects listed in the State Work Plan.

6. The estimated financial contributions to be provided by the Commonwealth are outlined in Table 1.

## PART 4: PROJECT MILESTONES, REPORTING AND PAYMENTS

If the maximum Commonwealth payments shown in Table 1 are not made in a given financial year (e.g. due to lack of acceptable project proposals) the Commonwealth may move funds into a later year at its discretion. The Commonwealth makes no guarantee that unspent funding (if any) will be carried into later years.

9. If a milestone is met in advance of the due date, where the State demonstrates that the milestone has been met, the Commonwealth may make the associated payment earlier than scheduled provided it falls within the same financial year as the original milestone date.
10. The State will provide the annual performance report in accordance with Table 2 during the operation of the Agreement. Each performance report is to:
  - a. contain a description of actual performance against projects and/or activities listed in the State Work Plan in the period to date against the project milestones;
  - b. demonstrate funding contributions from the State and/or third parties at least matches the Commonwealth's contribution;
  - c. include information on any issues which could adversely impact the delivery of the Improving Great Artesian Basin Drought Resilience program; and the State's proposal for managing or resolving outstanding matters; and
  - d. demonstrate how each project (as listed in the State Work Plan) has contributed to achieving key outcomes of the Great Artesian Basin Strategic Management Plan (once finalised).
11. The annual performance report must be provided by 30 April each year in the form of any relevant template(s) provided by the Commonwealth.
