

Deed of Variation to the 12-month Skills Agreement

FEDERATION FUNDING AGREEMENT – EDUCATION AND SKILLS

Preliminaries

1. In accordance with clause 36 of the Education and Skills Federation Funding Agreement, the Parties agree to amend the 12-month Skills Agreement as set out in this Deed of Variation.
