# Variation Agreement extending the National School Reform Agreement

## Preliminaries

- 1. In accordance with clause 20 of the National School Reform Agreement (the Agreement), the Parties agree to amend the Agreement as set out in this Variation Agreement.
- 2. In December 2022, Education Ministers agreed to undertake a review to inform the next Agreement. To enable time for this review, Education Ministers agreed to extend the current Agreement for 12 months, subject to agreement from First Ministers.
