FEDERATION FUNDING AGREEMENT – INFRASTRUCTURE

Table 1: Formalities and operation of schedule

Parties	Commonwealth Tasmania
Duration	This Schedule will commence as soon as the Commonwealth and the Tasmanian Governments sign it and will expire on 31 December 2023 or on completion of the projects, including final performance reports, unless terminated earlier or extended as agreed in writing by the Parties.
Purpose	This Schedule will support the delivery of the Regional Recovery Partnership in the Tasmania region. This Partnership supports existing state and regional recovery plans with a package of targeted initiatives to deliver jobs, economic recovery and economic diversification.
Partnership project purposes	The projects under the Partnerships are: <ul style="list-style-type: none"> – Dulverton Organic Transformation – waste management: construction of a purpose-built organic waste processing facility to service industry sectors and domestic households in the North West Tasmanian region. – Devonport Sound and Light Show: creation of a unique and immersive light and sound show that showcases Tasmania's landscapes and supports our domestic gateway. – Strahan Waterfront: creation of a modern, safe part precinct to increase the space for locals and tourists. This will support the aquaculture industry and the tourism and arts on the west coast. – Antarctic Precinct – Centre of Excellence Space Research: re-commission of the previous generation hyperbaric chamber as a spacecraft/planetary-habitat simulator for long-duration spaceflight simulation.
Estimated financial contributions	The Commonwealth will provide an estimated total financial contribution to Tasmania of \$10.0 m in respect of this Schedule. Co-contributions are strong with the Tasmanian Government providing a contribution of \$5.51m, local government \$1.5m and a not-for-profit Tasmanian business \$5m as set out in Table 1. All contributions will be additional to existing Commonwealth and State investments. On commencement of the Schedule, \$10.0 million will be paid.

* Tasmania is not required to provide financial and/or in-kind contributions under the terms of this Agreement, however it allocates its own source funding and provides in-kind contributions to support achievement of the outputs of this Agreement.

Reporting arrangements	Tables 2A-D summarise the milestones for the projects, their relationships to the outputs, expected completion dates, relevant reporting dates and expected payments to be made. The Tasmanian Government will provide performance reports in accordance with Tables 2A-D during the operation of the Schedule. Each performance report is to contain tracking of actual performance in the period to date against project milestones across all regions and advice on any broader policy issues impacting on Partnership delivery. The reports, as appropriate, should also explain how projects have contributed to Partnership objectives in particular creating jobs, economic growth and economic diversification in each location, and how the project's impact has been amplified by other partners' efforts.					
Evaluation	The Commonwealth will be responsible for conducting an evaluation of the Partnerships and initiatives delivered under this Agreement in 2022-23. Tasmania and other project proponents will be responsible for participating in the evaluation. Tasmania is to provide a summary of initiatives implemented under each Partnership, and outcomes they have and are expected to achieve, including a statement on the completion of all capital works for these projects.					
Shared roles	All Parties will continue to broker solutions between their different governments to help align efforts to assist economic recovery in the different regions. All parties will commit to best practice governance arrangements in order to deliver the reports and Partnerships in a timely manner. In addition, Schedule E, Clause 26 of the IGA FFR outcomes will be applicable to projects funded under Partnerships.
