Parties	Commonwealth Tasmania																												
Duration	This Schedule will commence when the Commonwealth and Tasmania sign the schedule and is expected to expire on 30 June 2029. It will be reviewed by 30 June 2026. It can also be changed at any time with the agreement of both parties.																												
Purpose	This Schedule will help people who are experiencing or at risk of homelessness and support the effective operation of Tasmania's social housing and homelessness services sectors. In committing to this Schedule, the Parties acknowledge their mutual interest in preventing homelessness and improving social housing in Tasmania, with particular regard to people experiencing disproportionate housing inequality and disadvantage.																												
Estimated financial contributions	The Commonwealth will provide an estimated total financial contribution to Tasmania of \$195.3M in respect of this Schedule.
