## FEDERATION FUNDING AGREEMENT – INFRASTRUCTURE

### AMENDMENT 1

<b>Table 1: Formalities and operation of schedule</b>	
Parties	Commonwealth Queensland
Duration	This amended Schedule will commence as soon as the Commonwealth and Queensland Government sign it and will expire on 31 December 2023 or on completion of the projects, including final performance reports, unless terminated earlier or extended as agreed in writing by the Parties.
Purpose	This Schedule will support the delivery of the Regional Recovery Partnerships in identified regions (Cairns and Tropical North Queensland, Gladstone and Mackay-Isaac-Whitsunday). These Partnerships support existing state and regional recovery plans with a package of targeted initiatives to deliver jobs, economic recovery and economic diversification.
Partnership project purposes	<p>The projects under the Partnerships are:</p> <ul style="list-style-type: none"> <li>- <b>Cairns and Tropical North Queensland:</b> <u>Cairns Gallery Precinct Development - Stage 2-5a</u> - During 2020, Stage One delivered the restored and refurbished former Cairns Courthouse now operating as an Indigenous art gallery and events venue. Works to be completed under this Agreement include the demolition of the existing building at 51 The Esplanade, heritage refurbishment and upgrade of the former shire offices on the Cairns Esplanade, upgrade and modifications, connectivity and landscaping to the existing Cairns Art Gallery and a detailed design for a new world-class Indigenous Art Gallery including wider precinct integration.</li> <li>- <b>Gladstone:</b> <u>Central Queensland Hydrogen Ecosystem Development</u> - The consortium will establish a Central Queensland hydrogen knowledge base centred in Gladstone to test transporting, storing and dispensing renewable hydrogen as a liquid and compressed gas via re-fuelers and establish design principles for an export terminal for liquid hydrogen. Establishing a renewable hydrogen ecosystem development pilot will facilitate investment in hydrogen fuel cell electric cars, trucks, buses, ferries and locomotives; attract technologists to the</li> </ul>

	<p>region to view an integrated technology demonstration site; and provide a real life testing environment for hydrogen technology providers and further research.</p> <ul style="list-style-type: none"> <li>- <u>Auckland Hill (Harbour Outlook) Economic Development</u> – This project will provide additional footpaths and access between the Marina and Harbour lookouts, refurbish and extend the existing Harbour lookout, provide additional parking and refurbish the café open dining area.</li> <li>- <b>Mackay-Isaac-Whitsunday:</b> <u>Biocommodities Pilot Expansion</u> - This project will support Queensland University of Technology’s (QUT) development of regional bio-manufacturing industries in synthetic biology, green chemicals and future foods. The partial expansion and equipment upgrades of the ten year old Biocommodities Pilot Plant, owned and operated by QUT, will enhance the region’s capability in scaling up fermentation processes for synthetic biology and future foods technologies.</li> <li>- <u>Clermont Saleyards &amp; Showgrounds Upgrade (Stage 2)</u> - Improved infrastructure and technology upgrades to support more efficient cattle transport and saleyard operations. The project will also refurbish the existing show pavilion to create a multi-user space.</li> <li>- <u>Aquaculture + Agriculture Tech Skills Hub</u> - will provide ag-tech program delivery and training that is aligned to industry requirements.</li> </ul>

The reports, as appropriate, should also explain how projects have contributed to Partnership objectives in particular creating jobs, economic growth and economic diversification in each location, and how the project's impact has been amplified by other partners' efforts.</p>
Evaluation	<p>The Commonwealth will be responsible for conducting an evaluation of the Partnerships and initiatives delivered under this Agreement in 2022-23. Queensland and other project proponents will be responsible for participating in the evaluation.</p> <p>Queensland is to provide a summary of initiatives implemented under each Partnership, and outcomes they have and are expected to achieve, including a statement on the completion of all works for these projects.</p>
Shared roles	<p>All Parties will continue to broker solutions between their different governments to help align efforts to assist economic recovery in the different regions.</p> <p>All parties will commit to best practice governance arrangements in order to deliver the reports and Partnerships in a timely manner.</p> <p>In addition, Schedule E, Clause 26 of the IGA FFR outcomes will be applicable to projects funded under Partnerships.</p>


