4.	South Australia will comply with all relevant laws, regulations and policies outlined in MoU between National Forestry and Grassland Administration of the People's Republic of China and South Australia's Department for Environment and Water on Cooperation of Promoting Giant Panda Conversation and the Cooperative Research Agreement for the International Conservation of Giant Pandas between CWCA and Adelaide Zoo that apply to the initiative, including those in Australia and in the partner Country as well as the Convention on International Trade in Endangered Species of Wild Fauna and Flora.
5.	South Australia will advise the Commonwealth of any issues regarding the implementation of MoU between National Forestry and Grassland Administration of the People's Republic of China and South Australia's Department for Environment and Water on Cooperation of Promoting Giant Panda Conversation and the Cooperative Research Agreement for the International Conservation of Giant Pandas between CWCA and Adelaide Zoo.
6.	In addition to termination under paragraph 39 of the Federation Funding Agreement – Environment, the Commonwealth may terminate this schedule any time by notice in writing if:
	a) relevant export and import licences for the two Giant Pandas, their cubs and derivatives (if any) at Adelaide Zoo are not able to be obtained;
	 b) the MoU between National Forestry and Grassland Administration of the People's Republic of China and South Australia's Department for Environment and Water is breached, expires or is terminated; or
	c) the Cooperative Research Agreement between CWCA and the Adelaide Zoo is breached, expires or is terminated.
