# Workload Reduction Fund Action 12 of the National Teacher Workforce Action Plan FEDERATION FUNDING AGREEMENT - EDUCATION AND SKILLS

Duration	This Schedule is expected to expire on 30 September 2027 or on completion of the initiatives, including final performance reporting and processing of final payments against milestones.
Purpose	This Schedule supports Action 12 of the National Teacher Workforce Action Plan: To pilot new approaches to reduce teacher workload through a Workload Reduction Fund to maximise the value of a teacher's time.
	This Schedule supports the delivery of the School Administration Improvement Program pilot, the NSWEduChat Trial Expansion to All Staff pilot, the School Admin Reduction Program pilot, the Mastery in Mathematics pilot, the Cechat – A Generative Al in Schools pilot, and the Reducing Teacher Workload: Assessment, Marking and Feedback pilot.
	Any further projects are to be determined by mutual agreement between parties and specified through amendments to this Schedule and accompanied by additional implementation plans.
	School Administration Improvement Program pilot
	This pilot will provide additional funding to schools to alleviate immediate administrative workload pressure points through the allocation of additional School Administrative and Support Staff (SASS). The Commonwealth co-funded pilot will deliver an additional cohort of SASS support to the schools most in need.
	The Pilot will:  • deliver 22 additional support and administrative staff FTE across 19 schools and target schools with low socio-economic indicators who have volunteered to be part of a broader

- School Administration Improvement Program
- encourage schools to think differently around how administrative / non-teacher work can be reallocated from a teacher to alternative support resourcing.

## NSWEduChat Trial Expansion to All Staff pilot

NSWEduChat is a teaching and learning tool powered by generative artificial intelligence (AI), which can support teachers with a range of teaching, learning and administrative tasks, including:

- support for explicit teaching idea generation, differentiated learning resource materials, marking criteria creation and student feedback
- · policy retrieval
- · communication tasks such as emails and newsletters.

The pilot supports the expansion of the NSWEduChat trial to enable access for all staff system-wide, with the aim of increasing understanding of:

- NSWEduChat's impact on teacher workload reduction
- · opportunities to use AI to assist teachers.

Specifically, the pilot will support the scaling of NSWEduChat to staff in approximately 700 schools and fund an additional feature allowing users to upload documents, to assist with workload reduction.

The pilot aligns to the Australian Framework for Generative Artificial Intelligence in Schools and the NSW Artificial Intelligence
Assessment Framework.

#### School Admin Reduction Program pilot

Building on the School Administration Improvement Program implemented across 2023-24, this pilot will provide 25.2 Full Time Equivalent (FTE) additional administrative support staff across approximately 66 New South Wales government sector schools for Terms 2-4 of the 2025 New South Wales public school calendar year (28 April – 19 December 2025).

The pilot will also support teacher and school leader workload reduction through:

- guidance and development of central resources on administrative and operational processes with consideration to diverse school settings
- additional support and guidance on using additional administrative staff resourcing strategically to meet local school needs and ensure sustained felt benefits
- role specific professional development training and capability uplift for administrative staff.

#### Mastery in Mathematics pilot

(implementation led by the National Catholic Education Commission)

This pilot contributes to the development and delivery of practical and adaptable curriculum resources and professional learning support in Year 9 and 10 mathematics, aligned to Stage 5 of the NSW Syllabus, the Australian Curriculum V9.0 and the Victorian Curriculum V2.0.

The pilot contributes to the delivery of:

- · curriculum maps to support schools' planning
- adaptable and editable classroom materials including teacher presentation slides, student worksheets, reteach slides, daily review slide packs, checks for prior knowledge and formative lesson assessments (quizzes)
- professional learning to support teachers to implement resources with rigour and fidelity
- additional resources to support intervention for Year 9 and 10 students who have gaps in foundational numeracy skills, especially those facing systemic disadvantage and with diverse needs.

The resources will be freely available online to all teachers across all sectors and all jurisdictions for a minimum of three years.

#### Cechat - A Generative AI in Schools pilot

(implementation led by Catholic Schools NSW)

This pilot involves an AI-powered chatbot, tailored for Catholic education institutions across Australia, designed to reduce administrative burdens, streamline communication, and provide pedagogical support to educators. Cechat will be piloted in selected schools, with a focus on reducing teacher workloads by automating routine tasks and supporting educational leadership.

The pilot will support teacher workload reduction through:

- use of Al to reduce administrative burden of filling in forms
- generation of lesson plans and valuable, relevant class activities
- transcription of notes, conversations and other communications
- summarisation and analysis of student data
- developing and delivering an AI strategy within CEnet to support existing and emerging school related business functions.

Cechat is being developed with a specific emphasis on supporting schools facing systemic disadvantage and assisting teachers working with students with diverse needs.

The pilot will comply with the Australian Framework for Generative Artificial Intelligence in Schools.

Reducing Teacher Workload: Assessment, Marking and Feedback pilot

(implementation led by the Association of Independent Schools of NSW)

This pilot will trial the application of a Teacher Workload Reduction Framework across multiple Independent schools, incorporating the use of tools including generative AI to reduce the time teachers spend each week on marking, assessment and feedback. The pilot's objective is to reduce the volume of hours spent by teachers on marking, assessment and feedback, allowing more time to be spent

on other core teaching tasks and collaboration.

The pilot will include:

- developing the Teacher Workload Reduction Framework and developing and delivering the training for pilot schools to implement it
- providing release time for teachers in pilot schools to undertake the required training, implement the Framework and apply the tools, and complete related trial activities
- engaging any relevant academics or other external personnel to act as advisors or subject matter experts, or licensing any technology required to undertake the trial.

The pilot will comply with the Australian Framework for Generative Artificial Intelligence in Schools.

# Estimated financial contributions

The Commonwealth will provide an estimated total financial contribution of \$4.8m to NSW in respect of this Schedule.
