NATIONAL PARTNERSHIP ON RECYCLING INFRASTRUCTURE

PART 1: PRELIMINARIES

- A1 This Schedule has been developed in accordance with clause 15 of the National Partnership Agreement on Recycling Infrastructure and should be read in conjunction with that Agreement.
- A2 This Schedule will commence as soon as it is signed by the Commonwealth and South Australia, and will expire on 30 June 2027 or on completion of final performance reporting and processing of final payments against milestones, whichever is later.

PART 2: DELIVERY OF PROJECTS IN SOUTH AUSTRALIA

- A3 Under this Schedule, South Australia agrees to facilitate achievement of the outcomes of the Agreement:
 - a) Through a competitive grants funding program open to private sector, non-government organisations and local government applicants. (Part 2A of this Schedule refers).
 - b) If agreed by the Commonwealth by identifying individual projects that enhance recycling and re-use capacity and capability in South Australia.
 - c) Through delivery of a 40,000 tonne per annum fibre polishing plant adjacent to the Northern Adelaide Waste Management Authority by 30 November 2025 (Part 2B of this Schedule refers).
- A4 Projects delivered by South Australia under A3 of this Schedule will require at least a matching contribution of funding from proponents consistent with clause 19 of the Agreement.

PART 2A: DELIVERY OF GRANTS PROGRAMS

- A5 The grants program delivered by South Australia will prioritise the following categories of projects:
 - a) Mixed plastics reprocessing
 - b) Increasing soft plastics processing capacity
 - c) Commercialisation of new plastic separation technology
 - d) Increasing glass remanufacturing capacity
- A6 South Australia agrees to publish grant guidelines and provide a copy of the guidelines to the Commonwealth before approving any grants under this program. Officials from the South Australian and Commonwealth governments will jointly agree grant assessment criteria in accordance with the eligibility criteria in Appendix A to this Agreement. South Australia agrees that all pending decisions on successful grants will be provided to the Commonwealth before a

final decision is announced, and that prior agreement is reached on the nature and content of any events, announcements, promotional material or publicity relating to projects awarded by states under this Agreement, and that the roles of both Parties will be acknowledged and recognised appropriately.

- A7 The projects will be co-funded by the Commonwealth and South Australia with third party contributions as set out in clause 19 of the Agreement.
 - a) For the purposes of subclause 19(a) of the Agreement, the Commonwealth agrees to recognise South Australia's previous commitments of \$1,112,906 for recycling infrastructure projects as part of its co-funding contribution under this Agreement. South Australia agrees to contribute an additional \$13,907,094 to meet its remaining co-funding requirements.
 - b) South Australia will report on the recycling infrastructure projects referred to in A7(a) of this Schedule consistent with Part 4: of the Agreement and Part 4 of this Schedule.
 - c) For the purposes of subclause 19(a) of the Agreement, South Australia will write to each grant proponent that has received funding as part of South Australia's prior commitments of \$1,112,906 to provide official acknowledgement that the Commonwealth co-funded those grants and is to also be recognised as a partner contributor in any public messaging, advertising, acknowledgements, events or similar, consistent with Part 14 of the Agreement.

PART 2B: DELIVERY OF A FIBRE POLISHING PLANT

A8 South Australia will deliver a fibre polishing plant adjacent to the Northern Adelaide Waste Management Authority by 30 November 2025, in accordance with the business case submitted to the Commonwealth, at a total estimated project cost of \$12,000,000.

PART 3: FINANCIAL ARRANGEMENTS

- A9 The Commonwealth will provide a maximum estimated financial contribution of \$18,980,000 to South Australia. All payments are GST exclusive.
 - a) Up to \$15,020,000 will be provided for the grants program outlined in Part 2A of this Schedule; and
 - b) Up to \$3,960,000 for a fibre polishing plant at Northern Adelaide Waste Management Authority as outlined in Part 2B of this Schedule.

A10 The estimated financial contribution to be provided by the Commonwealth is outlined in Table 1.

PART 4: PROJECT MILESTONES, REPORTING AND PAYMENTS

A11 If applicable, South Australia and the Commonwealth will work together on the appropriate utilisation of any funds recovered through a liquidation process that considers past payments and future commitments under this Schedule.

^{*}South Australia contributions include \$1,112,906 in previous commitments for recycling infrastructure. South Australia will provide an additional \$17,867,094 in funding over the Agreement period, which, together with the \$1,112,906 already committed, will make up South Australia's agreed co-contribution of \$18,980,000.00.

- Table 2A and 2B summarise the project milestones, their relationship to the outputs, expected completion dates, relevant reporting dates and expected payments to be made. The Commonwealth will make payments subject to South Australia demonstrating that the relevant milestone has been met. Multiple payments may be made against each milestone in a financial year, provided payments do not exceed the total Commonwealth contribution for that financial year.
- A12 If the maximum Commonwealth payments are not made in a given financial year (e.g. due to lack of acceptable project proposals) the Commonwealth may move funds into a later year at its discretion. The Commonwealth makes no guarantee that unspent funding (if any) will be carried into later years.
- A13 If applicable, South Australia and the Commonwealth will work together on the appropriate utilisation of any funds recovered through a liquidation process that considers past payments and future commitments under this Schedule.
