Dear Minister *Hannah*

I refer to the Commonwealth Accessible Australia initiative – Tranche One Federation Funding Agreement (the schedule) between the Commonwealth and the Government of Western Australia (WA) executed on 5 August 2025.

Under the schedule, the Commonwealth has committed to providing an additional one-off Project Coordination Fund (PCF) payment of \$112,639.80 to WA upon purchase or commencement of a total facility count of five or more eligible facilities.

The Department of Health, Disability and Ageing recently received advice from the Commonwealth Department of Treasury (Treasury) that the PCF is not included in the performance milestones under Table 2 of the signed schedule. Without a description of the milestone, payment date and payment amount, Treasury is unable to release the PCF payment.

To address this, the department is seeking your support to vary the schedule to include the one-off PCF milestone under Table 2. The updated schedule will be reflected through the additions at Attachment A to this letter, including due date, performance requirements and the financial contribution profile.

This letter, together with your signed response, will serve as the formal agreement between the Commonwealth and WA regarding this variation. Please indicate your agreement to these terms by providing a signed response to the department directly to AccessibleAustralia@health.gov.au by no later than **Thursday 16 October 2025**.
