### Evaluation Outcomes – Additional information

#### *Access PrEP medication for the target population*

- Funding under the Program can be used for the purchase of any oral PrEP medications available on the Pharmaceutical Benefits Scheme. States and Territories must ensure prescription and patient management adheres to the 2012 ASHM Australian PrEP Guidelines.

#### *Medium and long-term outcomes*

- The intent of these outcomes is to gather information from the implementation of the Program that can be compared to other HIV surveillance and reporting datasets for the purpose of determining whether the Program is contributing to Australia’s strategic policy objective of virtual elimination.



## Access to Pre-Exposure Prophylaxis (PrEP) for people who are not eligible for Medicare

The Access to PrEP for people who are not eligible for Medicare Program (the Program) is a joint Commonwealth and State and Territory initiative to provide access to PrEP to people at risk of HIV transmission living with HIV in Australia<sup>1</sup> who are not eligible for Medicare.

<sup>2</sup> A person is counted if at least one script has been issued and PrEP dispensed. We accept there might be some over counting due to movement of clients between jurisdictions. For example, a client might reside in Tasmania for 2 months of the year and have at least 1 script issued, and medications dispensed but reside in Victoria for remaining 10 months of the reporting period. The client will be counted in Victoria's total and Tasmania's total.
