Additional terms	<p>Tasmania will ensure the Commonwealth is kept informed about the expected delivery schedule for each project (expected major milestone delivery dates including completion) and advise the Commonwealth as soon as practicable of any significant deviations from agreed implementation plans.</p> <p>Tasmania will provide annual project status reports within three months of the end of each financial year (by 30 September) for each project until completion. Annual status reports will address progress towards achieving the objective of each output in the context of the delivery schedule for each project (and any relevant key performance indicators), as well as project expected activities within the coming 12 months. For the 'additional elective surgery and endoscopy procedures' output annual project status reports will report against the relevant key performance indicators set out in the relevant <i>Tasmanian Health Service Service Plan</i>.</p> <p>Annual status reports may be provided in conjunction with reports addressing performance milestones (see Table 2) where their timing is aligned (within 1 month).</p> <p>In regard to the 'additional elective surgery and endoscopy procedures in Tasmania from 2019-20 onwards initiative' the parties agree that the <i>Project Agreement for the Community Health and Hospitals Program Tasmania's 2018-19 Initiatives Schedule</i> is superseded by this Schedule and that all reporting for that initiative will occur in accordance with this Schedule.</p> <p>The National Health Reform Agreement (NHRA) provides that the Commonwealth will not fund a service where the same service, or any part of the same service, is otherwise funded by the Commonwealth. Tasmania will ensure that any claim for funding under the NHRA is not funding services, or any part of a service, provided for under this agreement and will maintain appropriate records.</p> <p>The <i>Health Insurance Act 1973</i> prohibits the payment of Medicare benefits where other government funding is provided for that service. Tasmania will ensure any agreements entered into to support the provision of services under this Schedule recognise the operation of the <i>Health Insurance Act 1973</i>.</p>


