PROJECT AGREEMENT ON PEST AND DISEASE PREPAREDNESS AND RESPONSE PROGRAMS

Duration	This Schedule is expected to expire on 31 December 2024.
Purpose	<p>The purpose of this Schedule is to support the delivery of the two-year strategy designed to find and eradicate all unknown electric ant infestations within an intensive timeframe, mitigating the risk of further spread.</p> <p>The activities under this schedule continue and build on work undertaken under Schedule B for the National Electric Ant Eradication Program (the Program) between 2017-18 to 2021-22, with a further intensive strategy for the period 2022-23 to 2023-24.</p>
Project Elements	<p>Queensland will deliver the actions set out in the <i>National Electric Ant Eradication Program Response Plan: Version 5</i> (the Response Plan), which was approved by the National Management Group (NMG) on 23 June 2022.</p> <p>The Response Plan increases Program capacity through additional staffing and re-invigorated community engagement messaging to ensure proactive surveillance activities are conducted effectively and awareness of electric ant throughout the agreed area of interest is increased. Since first defined in 2016–17 for proof of freedom spatial modelling, risk areas within the area of interest have been redefined using up-to-date Program knowledge and data. The principal components of the Response Plan are:</p> <ul style="list-style-type: none"> • Expansion of Program activities to ensure full operational capacity by January 2023. • Proactive surveillance activities to ensure that all unknown infestations within the area of interest in Far North Queensland are detected. • Completion of eradication activities on current and future infestations detected during the proactive surveillance period. • Compliance activities to ensure movement controls are applied effectively and monitored. • Analysis and publication of Program data. • Scientific trials to support operational activities. • Diagnostic services. • Training for key stakeholders on electric ant surveillance methods (luring), and basic identification tools.

<p>Estimated financial contributions</p>	<p>The agreed maximum financial contributions to the National Electric Ant Eradication Program are outlined in Table 1. Reporting obligations are set out in Table 2, but circumstances may give rise to additional reporting being sought in accordance with the NEBRA-like arrangements if requested by the National Management Group. 2. Each party will contribute funding in accordance with the financial commitments approved by the Agriculture Ministers' Meeting on 9 September 2022. 3. This Schedule will be reviewed in conjunction with reviews of the National Electric Ant Eradication Program and decisions by the National Management Group. 																


