Duration	This Schedule will commence as soon as both Parties sign it and will expire on completion of all projects and performance milestones under the Schedule. Expected date of completion for projects is 30 June 2026 or otherwise agreed between parties.																								
Purpose	This Schedule will support the delivery of projects relating to emergency management and disaster risk mitigation as agreed to in the October Federal Budget 2022-23 to increase the resilience of communities within Victoria. Funding provided under this Schedule will contribute to the delivery of the projects listed at Attachment A .

(4) The Implementation Plan will be developed by Victoria and provided to the Commonwealth for endorsement as soon as possible, but no later than three months after the commencement of this Schedule unless otherwise agreed by the Commonwealth.

(5) Victoria and the Commonwealth may mutually agree to vary or substitute projects that align with the program objectives or compliment the original commitment.

Performance monitoring and reporting

(6) The Parties acknowledge that payments under this agreement will be tied to the performance milestones at Table 2 Performance requirements and payment summary.

(7) The frequency and timing of reporting under this Schedule is set out at Table 2: Performance requirements and payment summary.

(8) The content requirements of reporting under this Schedule are set out in the Assurance and Reporting Framework for the Program, as issued by the Commonwealth and amended from time to time and to the extent that they are not inconsistent with the terms of this Schedule.

Reporting

(9) Throughout the project period, the Commonwealth may ask Victoria for ad-hoc reports, including but not limited to interim reports, details of media events, information requests from the Commonwealth Minister and meetings to discuss the project implementation.

(10) The Commonwealth may request financial declarations, requesting Victoria to provide a declaration that the funding was spent in accordance with the funding agreement and to report on any underspend of the funding.

Third parties


(11) Victoria may engage third parties to support the delivery of projects under this Schedule.


